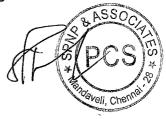

The Postal Ballot Notice dated October 16, 2023 were sent to 45305 shareholders vide electronic mode to their email addresses and mobile number registered with the Depository participant, as per the data downloaded from the CDSL as on November 03, 2023. The Company has completed dispatch of Postal Ballot Notice through email on Wednesday, November 08, 2023.

The remote e-voting period commenced on **Friday**, **the 10**th **November 2023**, **9 AM** and ended on **Saturday**, **9**th **December 2023**, **5 PM** for the Members exercising their vote through electronic voting. The remote e-voting module was disabled by CDSL for voting thereafter. All votes cast by e-voting through CDSL received upto 9th December 2023 at 5.00 PM being last date fixed by the Company for exercise of vote by electronic means, were considered for my scrutiny.

On scrutiny, I report that 114 Shareholders had exercised their vote through electronic voting (e-voting). The voting was reckoned in proportion to the paid-up value of the shares mentioned against the name of the Member in the Register of the Members on Friday, 3rd November, 2023.
