The Board of Directors of the company had approved the scheme of merger in its board meeting held on 07th July, 2023 and in continuation of the same, the company had filed an application with BSE on 02.08.23 for the approval. M/s BSE has sought further clarifications on the proposal and we are submitting a revised proposal in due course.
