- 1.2. 'BSE' is the abbreviation for BSE Limited being the only stock exchange, where presently the Equity Shares of the Target Company are listed.
- 1.3. 'Board of Directors' the Board of Directors of the Target Company.
- 1.4. **'CIN'** is the abbreviation for the term Corporate Identification Number issued under the provisions of the Companies Act, 1956/2013, and the rules made thereunder.
- 1.5. 'Equity Shares' shall mean the fully paid-up equity shares of the face value of Rs.10.00/- each.
- 1.6. 'Identified Date' means the date falling on the 10th Working Day prior to the commencement of the Tendering Period for the Offer to determine the Public Shareholders to whom the Letter of Offer shall be sent. It is clarified that all the Public Shareholders (registered or unregistered) who own Equity Shares are eligible to participate in this Offer at any time before the expiry of the Tendering Period.

'Offer' means an open offer being made by the Acquirer for acquisition of up to 6,75,428 Offer Shares representing 26.00% of the Voting Share Capital of the Target Company, at an offer price of ₹10.00/- per Offer Share, to the Public Shareholders of the Target Company, payable in cash, assuming full acceptance aggregating to a maximum consideration of aggregating to an amount of ₹67,54,280/- that will be offered to the Public Shareholders who validly tender their Equity Shares in the Offer.
- 1.10. 'Offer Documents' shall mean Public Announcement, Detailed Public Statement, Draft Letter of Offer, Letter of Offer, Recommendation of the Committee of the Independent Directors of the Company, Pre-Offer Cum Corrigendum to Detailed Public Statement, and Post Offer Public Announcement, and any other notices, advertisements, and corrigendum issued by or on behalf of the Manager.
- 1.11. 'Offer Price' is a price of ₹10.00/- per Offer Share, to the Public Shareholders of the Target Company, payable in cash, assuming full acceptance aggregating to a maximum consideration of aggregating to an amount of ₹67,54,280/- that will be offered to the Public Shareholders who validly tender their Equity Shares in the Offer.

- 1.12. **'Offer Shares'** means an open offer being made by the Acquirer for acquisition of up to 6,75,428 Offer Shares, representing 26.00% of the Voting Share Capital of the Target Company.

- 1.16. 'PAN' is the abbreviation for Permanent account number allotted under the Income Tax Act, 1961.
- 1.17. **'Public Announcement'** means the Public Announcement dated Friday, April 05, 2024, issued in accordance and compliance with the provisions of Regulations 3(1), and 4 read with Regulations 13 (1), 14, and 15 (1) of the SEBI (SAST) Regulations.
- 1.18. 'Public Shareholders' shall mean all the public shareholders of the Target Company who are eligible to tender their Equity Shares in the Open Offer, excluding the Acquirer, the existing promoters of the Target Company, and the parties to the Share Purchase Agreement including persons deemed to be acting in concert with such parties to the Share Purchase Agreement.
- 1.19. 'Sale Shares' shall mean 10,91,140 Sale Shares representing 42.00% of the Voting Share Capital of the Target Company.
- 1.20. 'SCRR' means Securities Contract (Regulation) Rules, 1957, as amended.
- 1.21. 'SEBI' means Securities and Exchange Board of India.
- 1.22. **SEBI (LODR) Regulations'** means Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 and subsequent amendment thereto.
- 1.23. **SEBI (SAST) Regulations'** means Securities and Exchange Board of India (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 and subsequent amendment thereto.
- 1.24. 'Share Purchase Agreement' refers to the share purchase agreement dated Friday, April 05, 2024 executed between the Acquirer and the Selling Promoter Shareholders, pursuant to which the Acquirer has agreed to acquire 10,91,140 Sale Shares representing 42.00% of the Voting Share Capital of the Target Company, at an offer price of ₹10.00/- per Sale Share, to the Public Shareholders of the Target Company, payable in cash, aggregating to a maximum consideration of ₹1,09,11,400/-, payable subject to the terms and conditions specified in the said Share Purchase Agreement .
- 1.25. 'Target Company' or 'SUERYAAKNI' refers to Sueryaa Knitwear Limited, a company incorporated under the provisions of the Companies Act, 1956, bearing corporate identity number 'L17115PB1995PLC015787', with its registered office located at 408, Industrial Area A, Ludhiana, Punjab 141003.
- 1.26. 'Tendering Period' means the period which shall have the meaning ascribed to it under Regulation 2(1)(za) of the SEBI (SAST) Regulations.
- 1.27. 'Underlying Transaction' refers to the transaction for sale and purchase of the Sale Shares as contemplated under the Share Purchase Agreement.
- 1.28. 'Working Day' refers to the day which shall have the meaning ascribed to it under Regulation 2(1)(zf) of the SEBI (SAST) Regulations.

Offer Size	The Acquirer hereby makes this Offer to the Public Shareholders of the Target Company to acquire up to 6,75,428 Offer Shares representing 26.00% of the Voting Share Capital of the Target Company, subject to the terms and conditions specified in this Public Announcement, the Detailed Public Statement, and the Letter of Offer, that are proposed to be issued in accordance with the SEBI (SAST) Regulations.
Offer Price / Consideration	The Offer is being made at a price of ₹10.00/- per Offer Share. The Equity Shares of the Target Company are infrequently traded in accordance with the provisions of Regulation 2 (1) (j) of the SEBI (SAST) Regulations, and hence the Offer Price has been determined in accordance with the parameters prescribed under Regulations 8 (1) and 8 (2) of the SEBI (SAST) Regulations. Assuming full acceptance under this Offer, the aggregate consideration payable to the Public Shareholders in accordance with the SEBI (SAST) Regulations will be ₹67,54,280.00/-, that will be offered to the Public Shareholders who validly tender their Equity Shares in the Offer.

3. TRANSACTION WHICH HAS TRIGGERED THE OPEN OFFER OBLIGATIONS (UNDERLYING TRANSACTION)

The Acquirer has entered into a Share Purchase Agreement dated Friday, April 05, 2024 with the Selling Promoter Shareholders, pursuant to which the Acquirer has agreed to acquire, 10,91,140 Sale Shares, which constitutes 42.00% of the Voting Share Capital of the Target Company for an aggregate consideration of ₹1,09,11,400.00/-, subject to the statutory approvals, if any and satisfaction of conditions precedent specified in the Share Purchase Agreement (unless waived off in accordance with the Share Purchase Agreement).

Pursuant to proposed acquisition of the aforesaid Sale Shares and Voting Share Capital of the Target Company in terms of the Share Purchase Agreement, the aggregate shareholding of the Acquirer in the Target Company would exceed the threshold limit prescribed under regulation 3(1) of the SEBI (SAST) Regulations.

Since the Acquirer has entered into the Share Purchase Agreement to acquire voting rights in excess of 25.00% of the Equity Shares and Voting Share Capital of the Target Company, accompanied with control, this Open Offer is being made under Regulation 3(1) and 4 of the SEBI (SAST) Regulations. Upon consummation of the Underlying Transaction contemplated in the Share Purchase Agreement and post successful completion of the Offer, the Acquirer will acquire control over the Target Company and the Acquirer shall become the promoter of the Target Company in accordance with the provisions of the SEBI (LODR) Regulations. Upon sale of the entire shareholding of the Selling Promoter Shareholders in the Target Company pursuant to the Share Purchase Agreement, they will cease to be members of the promoter and promoter group of the Target Company in accordance with the applicable law.

The proposed sale and purchase of Equity Shares by the Selling Promoter Shareholders and the Acquirer, respectively, under the Share Purchase Agreement (as explained in above paragraphs of this Public Announcement) is referred to as the "Underlying Transaction".
