Sub: Scrutinizer's Report on Postal Ballot and remote e-voting conducted pursuant to Section 108 & 110 of the Companies Act, 2013 ('the Act') read with Rule 20 & 22 of Companies (Management and Administration) Rules, 2014 ('the Rules') on agenda items stated in Postal Ballot Notice dated February 09, 2024 ("Postal Ballot").

I, Neeraj Jain (Membership No. F9599 and COP 26163), Proprietor of M/s. Neeraj Jain & Associates, Practicing Company Secretaries, having my office at 1511, R.G. Trade Tower, Netaji Subhash Place, Pitampura, New Delhi-110034, was appointed as the scrutinizer by the Board of Directors of **Omaxe Limited** ("the Company") for the purpose of scrutinizing the process of remote e-voting/postal ballot on the resolutions set out in the Postal Ballot Notice dated February 09, 2024 ("Postal Ballot Notice").

I hereby submit my Report as under that:

1. In terms of the provisions of Sections 108, 110 and other applicable provisions of the Companies Act, 2013 (including any amendment(s), statutory modification(s) and/ or re-enactment(s) thereof for the time being in force) read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014, as amended and in compliance with General Circulars No. 14/2020 dated April 8, 2020, 17/2020 dated April 13, 2020, 22/2020 dated June 15, 2020, 33/2020 dated September 28, 2020, 39/2020 dated December 31, 2020, 10/2021 dated June 23, 2021, 20/2021 dated December 08, 2021, 3/2022 dated May 05, 2022, 11/2022 dated December 28, 2022



09/2023 and dated September 25, 2023 issued by the Ministry of Corporate Affairs for holding general meetings/ conducting postal ballot (hereinafter collectively referred to as 'MCA Circulars'), the Company had completed dispatch of Postal Ballot Notice on February 28, 2024, all its eligible members through permitted mode.

- The Postal Ballot Notice was sent to those members of the Company, who have registered their email addresses with the Company / depository participants and whose name appeared in the Register of Members of the Company on February 23, 2024 ('cutoff date').
- 3. The remote e-voting facility for this Postal Ballot activity was provided by Link Intime India Private Limited ("LIIPL"), the Registrar and Share Transfer Agent of the Company.
- 4. Particulars related to remote e-voting communications received from the Members, if any, have been entered in a Register, separately maintained for the purpose.
- 5. The remote e-voting period remained open from Thursday, February 29, 2024 (09:00 A.M onwards) till Friday, March 29, 2024 (upto 5:00 P.M.).
- 6. All e-voting communications received upto the close of working hours i.e. 05:00 P.M. on Friday, March 29, 2024 (the last date and time fixed by the Company for e-voting) were considered for my scrutiny.
- 7. The e-voting module of LIIPL was disabled on Friday, March 29, 2024 at 05:00 P. M., immediately after completion of voting time period.
- 8. The votes cast through remote e-voting were unblocked on Friday, March 29, 2024, around 05:07 P.M. in the presence of two witnesses viz. Mr. Vikram Chourasia (PAN: BZQPC3785G) R/o D2-396A, Shiv Durga Vihar, Lakkarpur, Faridabad-121009, Haryana and Mr. Manoj Kumar (PAN: BCTPK8093D) R/o House No. A-1/28, FF, Block-A-1, Mohan Garden, Near Gandhi Chowk, Uttam Nagar, New Delhi -110059 (who are not in the employment of the Company).
