### EXPLANATORY STATEMENT

#### (PURSUANT TO SECTION 102 OF THE COMPANIES ACT, 2013)

As required by Section 102 of the Companies Act, 2013 ("Act"), the following explanatory statement sets out all material facts relating to the business mentioned under Item No. 1 of the accompanying Notice:

#### Item No. 1

Pursuant to the provisions of Section 180(1)(a) of the Companies Act, 2013 approval of the members of the Company is required to sell, lease or otherwise dispose of the whole or substantially the whole of the undertaking of the Company.

The sale, transfer and/or disposal of the whole or substantially whole of the foundry operations at three different locations may be termed as sale or disposal of undertakings under the provisions of Section 180 (1) (a) of the Companies Act, 2013. Therefore, the prior approval of members is being sought by way of special resolution and **also as per the new regulation 37A of SEBI (Listing Obligations and Disclosure Regulations) 2015 the approval of a majority of the minority shareholders.** 

# Further, the Company is in the process of negotiating the consideration and other terms & conditions with the potential purchaser(s) of the said manufacturing facilities.

The Board is of the opinion that the disposal of the said assets and subsequent consolidation of the operations will result in substantial savings in cost of production and administrative expenses.

The expected outcome of the sale will give us resources for a modernised consolidated operation and sufficient additional funding for activities aimed at business expansion. The Board does not expect any disruption to current revenues during this process.

Hence, the Board recommends passing of the resolution as set out under Item No. 1 of the accompanying notice by the shareholders as a special resolution.

None of the Directors / Key Managerial Personnel and their relatives are in any way, concerned or interested, financially or otherwise, in the resolutions set out in Item No. 1.
