I, Shekhar Ghatpande Company Secretary in practice, having Membership No FCS:1659 and CP: 782 and having my office at 13, 'Saraswati' 3rd Floor Rambaug Colony, Paud Road, Kothrud, Pune 411038 have been appointed as a Scrutinizer for the purpose of scrutinizing the E- Voting process & ascertaining the requisite majority on E-voting carried out as per the provisions of Section 108 of the Companies Act, 2013 and Rule 20 of the Companies (Management and Administration) Rules, 2014 and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as well as on Voting process on Poll through Physical Ballot Forms, under the provisions of Section 109 of the Act read with Rule 21 of Rules, in a fair and transparent manner, on the Resolution at Item No. 1 contained in the Notice dated Friday, 14th December, 2018 of the Extra Ordinary General Meeting (EGM) (Notice) of the Members of Bilcare Limited (the Company), held on Friday,



11th January, 2019 at 11.00 A.M. at the Registered Office of the Company situated at 1028, Shirol, Rajgurunagar, Pune - 410505.

The Management of the Company is responsible to ensure the compliance with the requirements of the Act, and Rules relating to E- Voting and Poll on the Resolutions contained in the Notice of Extra Ordinary General Meeting of the Members of the Company. My responsibility as a Scrutinizer for the E-Voting and for conducting Poll was restricted to make a Scrutinizer's Report of E-Voting and Poll, of the votes cast "in favour" or "against" the Resolution stated in the Notice, based on the reports generated from the E-Voting system provided by Central Depository Services Limited (CDSL) and also during the Extra Ordinary General Meeting on the Poll through physical Ballot Form.

I submit my Report on the same as under:

- 1) That the Company had made necessary arrangements with Central Depository Services Limited (CDSL) for facilitating remote E-Voting to the Members to enable them to cast their votes electronically.
- 2) That the EVSN allotted by CDSL for Electronic Voting was 181217005.
- 3) That the E-Voting period allowed to the Members was from 9.00 A.M. (Starting Time) on Tuesday, 8th January, 2019 to 5.00 P.M. (Ending Time) on Thursday, 10th January, 2019.
- 4) That the Shareholders holding Equity Shares as on the "Cut Off" date i.e. Friday, 4th January, 2019 were entitled to vote on the proposed Resolution mentioned at Item No. 1 as set out in the Notice convening the Extra Ordinary General Meeting of the Company. The said Notice of Extra Ordinary General Meeting is attached herewith as **Annexure I** to this Report.



- 5) That the Paid up Equity Share Capital of the Company is Rs. 23,54,52,310/- divided into 2,35,45,231 Equity Shares of Rs. 10/- each fully paid up. The voting rights allowed by the Company was One Vote for every One Equity Share held in the Company.
- 6) The E-Votes were unblocked on Friday 11th January, 2019 at the conclusion of the Extra Ordinary General Meeting in the presence of two witnesses, Mr. Prabhanjan Ghatpande presently residing at Flat No 403, Sun-horizon, Near D-Mart, Baner Pune-411045 and Ms. Shambhavi Wagle presently residing at C2/602, Kumar Parisar, Kothrud, Pune-411038 who are not in the employment of the Company. They have signed below in confirmation of the votes being unblocked in their presence.
- 7) Thereafter, the details containing, inter-alia, list of Equity Shareholders, who voted "For" and "Against" were downloaded from the E-Voting website of Central Depository Services Limited (CDSL) (<http://www.evotingindia.com>)
- 8) 16 (Sixteen) Shareholders of the Company holding 71,28,181 Equity Shares have exercised their right of Voting through the process of E-Voting.
- 9) In respect of Physical Ballot Forms during the course of the proceedings of the Extra Ordinary General Meeting of the Company, all the Shareholders/ Proxies who have attended the Meeting and had not exercised their right of voting through E-Voting process, were requested to cast their Votes through Physical Ballot Forms.

After the time fixed for closing of the Poll by the Chairman of the Company, and after having ensured that such Shareholders/ Proxies had exercised their right of voting through Physical Ballot Form, Ballot Box kept for polling was sealed in my presence with due identification marks placed by me.



- 10) The sealed Ballot Box was subsequently opened in my presence along with the two witnesses named in Para No. 6 above and Poll Papers were diligently scrutinized. The Poll Papers were reconciled with the records maintained by the Company/ Registrar and Transfer Agents of the Company and the authorizations/proxies lodged with the Company.
- 11) The Poll Papers, which were incomplete and /or which were otherwise found defective were required to be treated as invalid, however I did not find any Poll Paper invalid.
- 12) 19 (Nineteen) Shareholders / Proxies of the Company holding 38,731 Equity Shares have exercised their right of Voting through the process of Physical Ballot Forms.
- 13) The summary of the Votes cast by the Shareholders of the Company, on the basis of E-Voting and Voting through the process of Physical Ballot Forms on Special Resolution as set out in the Notice, is attached separately to this Report as **Annexure II**, which forms part of this Report.
- 14) On the basis of the same, I submit herewith my Combined Final Report on the Result of E-Voting together with the Poll as under:



"RESOLVED THAT in accordance with Regulation 24 & other applicable provisions of the of SEBI (Listing Obligations & Disclosure Requirement) Regulations, 2015, read with Section 108 and other applicable provisions of the Companies Act, 2013, rules thereunder, including any statutory modification(s) and amendments to each of the foregoing and applicable notifications, clarifications, circulars, rules and regulations issued by the Government of India or other Government or statutory authorities, and subject to the Memorandum and Article of Association of the Company, the requisite approvals if any, of any relevant statutory, regulatory or government authorities, and further subject to such terms and conditions as may be prescribed by any of the aforesaid authorities while granting such approvals, the consent, approval of the Company be and is hereby accorded to the Board of Directors of the Company (hereinafter referred the "Board" which term shall be deemed to include any constituted Committee of the Board) to divest part or whole investment in its step down subsidiary(ies), thereby affecting control over these Subsidiary(ies) by way of such transactions including but without limitation to lease, joint venture, sale of one or more divisions, contribution of minority / majority stake in the Subsidiary(ies) or a division thereof on such terms and conditions as the Board of Directors of the Company may deem fit and appropriate in the best interests of the Company;

1. The Explanatory Statement pursuant to Section 102(1) of the Companies Act, 2013, in respect of the special business is annexed herewith.
2. A MEMBER ENTITLED TO ATTEND AND VOTE AT THE MEETING IS ENTITLED TO APPOINT A PROXY TO ATTEND AND VOTE ON A POLL INSTEAD OF HIMSELF/ HERSELF AND THE PROXY NEED NOT BE A MEMBER OF THE COMPANY.
3. The instrument appointing proxy should, however, be deposited at the Registered Office of the Company duly completed and signed not less than forty eight (48) hours before the commencement of the Meeting. Proxies submitted on behalf of limited companies, societies, etc. must be supported by appropriate resolutions/authority as applicable. A person can act as proxy on behalf of Members not exceeding 50 (Fifty) and holding in the aggregate not more than 10% (Ten percent) of the total share capital of the Company. In case, a proxy is proposed to be appointed by a Member holding more than 10% (Ten percent) of the total share capital of the Company carrying voting rights, then such proxy shall not act as a proxy for any other person or Member.
4. Corporate Members are requested to send board resolution duly certified, authorising their representative to attend and vote on their behalf at the meeting.

EXPLANATORY STATEMENT

As required by Section 102 of the Companies Act, 2013, the following Explanatory Statement sets out material facts relating to the special business of the accompanying Notice dated 14th December 2018.

Currently Company is undergoing debt resolution and restructuring process. To augment the resources, improve capital structure & strengthen its operations, Company proposes to raise fund by divesting overseas investments.

As per Regulation 24 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015; a listed entity shall not dispose of a part or whole of its undertaking and/or dispose of its shares in its material subsidiary resulting in a reduction of its shareholding (either on its own or together with other subsidiaries) to less than fifty percent or cease the exercise of control of the subsidiary without passing a special resolution.

Hence the said enabling resolution for approval of members of the Company by way of Special Resolution.

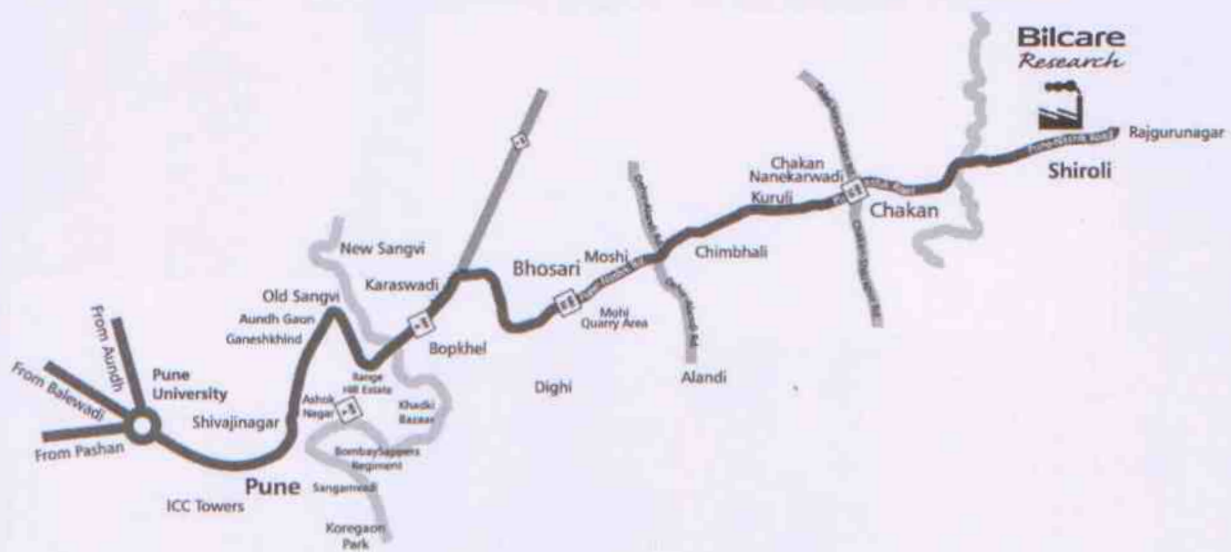
