दिलीप वळसे - पाटील यांचे मत लोकसत्ता प्रतिनिधी

पुणे : आरक्षणाच्या मुद्दचावर कोणीही टोकाची भूमिका घेणे योग्य नाही. कोणत्याही समाजाच्या आरक्षणाला धक्का न लावता मराठा समाजाला आरक्षण देण्याचा राज्य सरकारचा प्रयत्न आहे, अशी प्रतिक्रिया राज्याचे सहकारमंत्री दिलीप वळसे-पाटील यांनी येथे दिली.

मराठा समाजाला ओबीसी प्रवर्गातून आरक्षण देण्याच्या मुझ्यावरून सध्या वाद सुरू झाला आहे. त्यावरून मंत्र्यांमध्येही मतभेद असून मंत्री छगन भुजबळ यांनी ओबीसी प्रवर्गातून आरक्षण देण्यास विरोध दर्शविला आहे. या पार्श्वभूमीवर दिलीप वळसे पाटील यांच्याकडे विचारणा केली असता त्यांनी ही भूमिका मांडली. रयत शिक्षण संस्थेच्या बैठकीनंतर त्यांनी पत्रकारांशी संवाद साधला.




