

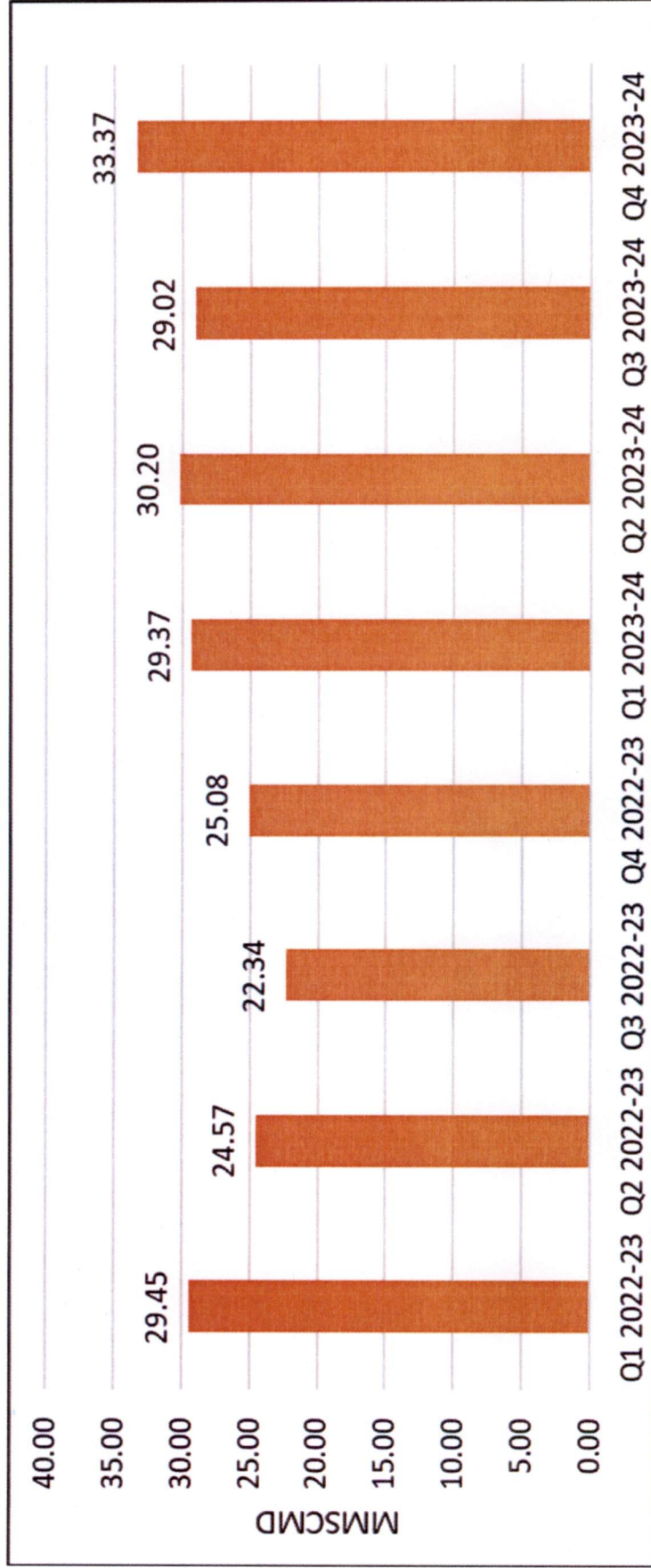

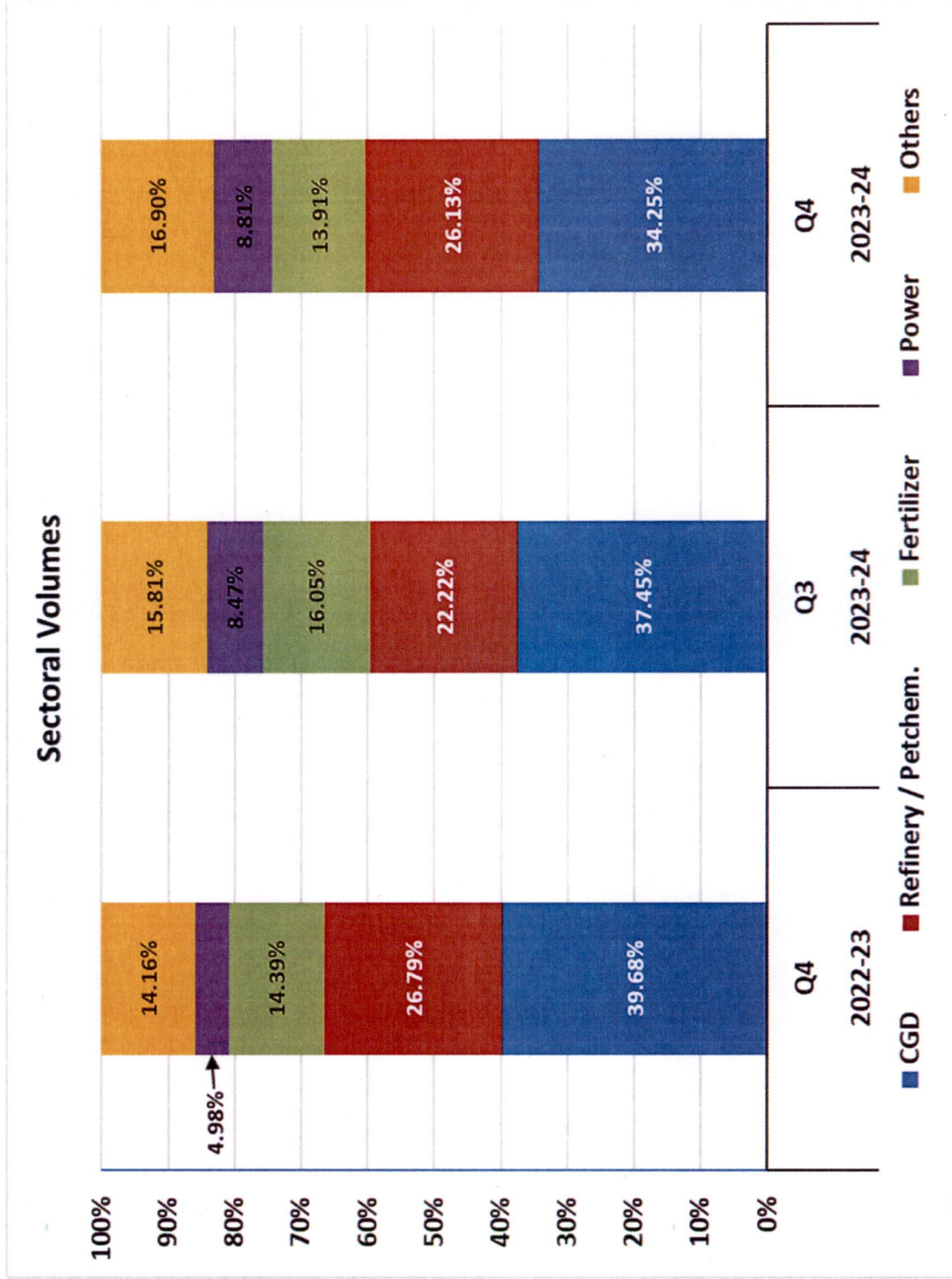

VOLUMES IN GSPL NETWORK



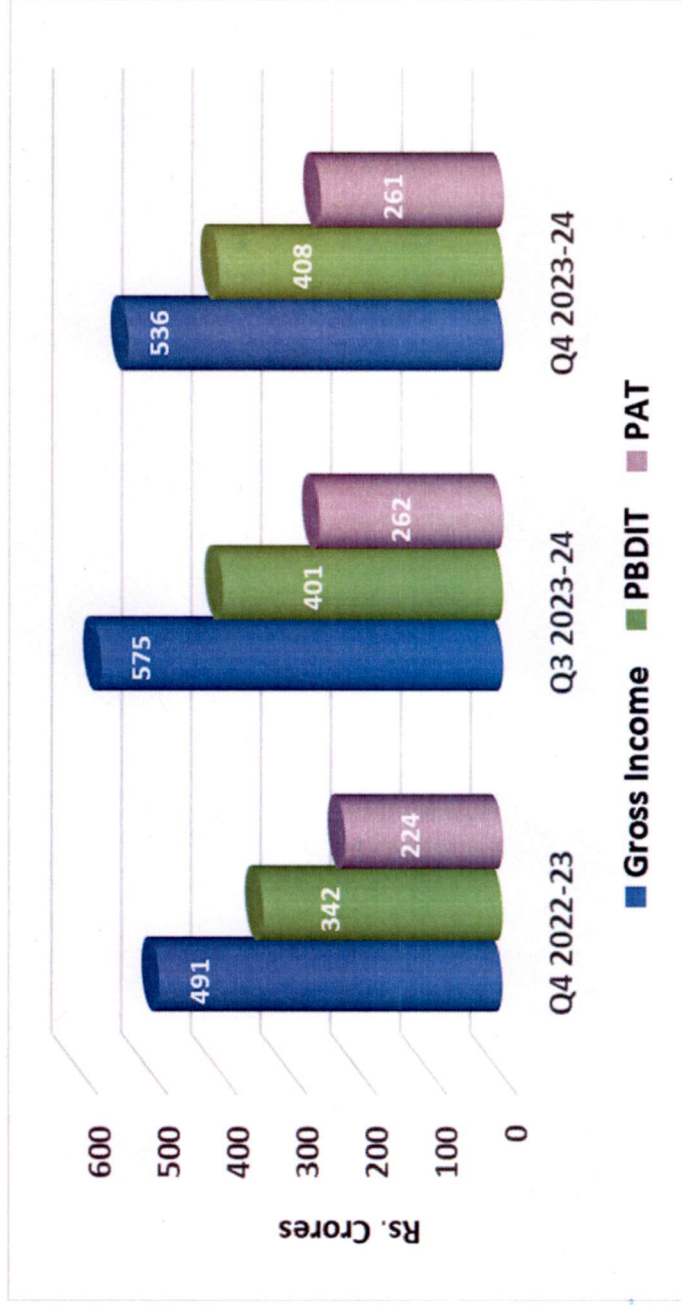
