WR COLLECTS 94.51 CRORE AS FINE DURING INTENSIVE TICKET CHECKING DRIVES DURING APRIL TO OCTOBER 2023



Ahmedabad, In order to ensure hassle-free, comfortable travel & better services to all bonafide passengers over Western Railway, intensive ticket checking drives are being carried out continuously over Mumbai suburban local services, Mail/Express as well as passenger trains & holiday special trains so as to curb the menace of ticketless/irregular passengers. The highly motivated ticket checking team under the supervision of senior commercial officers of Western Railway organized several ticket checking drives during the months from April to October 2023, thereby recovering an amount to the tune of Rs. 94.51 Crore, which also includes Rs. 24.38 Cr from Mumbai Suburban section. According to a press release

issued by Shri Sumit Thakur - Chief Public Relations Officer of Western Railway, during the month of October 2023, an amount of Rs.13.32 crore was recovered through detection of 2.17 lakh ticketless/irregular passengers, including unbooked luggage cases. Delay in Gujarat-bound trains due to OHE breakdown near Mumbai



AHMEDABAD: Gujarat-bound trains on the Western Railway route faced a significant delay of almost 12 hours due to an overhead equipment "breakdown" near Dahanu station in Maharashtra's Palghar district, close to Mumbai. This caused inconvenience to passengers traveling between Mumbai and Ahmedabad, which typically takes about eight

hours. According to Sumit Thakur, the chief public relations officer of Western Railway, the OHE breakdown occurred at Dahanu Road station at 11 pm on Wednesday. The UP (Mumbai-bound) line was cleared after midnight, around 12.15 am, while the DOWN (Gujarat-bound) line was restored at 10.25 am on Wednesday. However, a speed restriction of 60 kmph has been imposed in the section where the breakdown occurred. To minimize the impact on passengers, all trains are being given halt at every station in the Virar-Surat section. Fortunately, the suburban trains between Churghate and Virar are unaffected by this situation, as confirmed by Thakur. An official from Western Railway mentioned that the trains departing from Mumbai late Tuesday night were particularly affected by the incident, which took place between Dahanu and Dahanu stations. Help Desks have been set up at various stations to assist passengers facing delays. The District Railway Manager (DRM) of Western Railway expressed regret for the inconvenience caused, providing this information nearly three hours after the incident occurred.

RESERVE RAILWAY WAY COMMISSIONERS THE 6th LINE BETWEEN KHAR & GOREGAON

Ahmedabad, Western Railway, on 5th November, 2023, successfully completed the infrastructural work of 6th line on the 8 km stretch between Khar - Goregaon and achieved Speed Trial of 112 kmph over this section. The work which commenced on 7th October, 2023 consisted of Pre-Trial Work. Order of 30 nights and Traffic Works Order (TWO) of 29 nights including Non - Interlocking work (NI) of 10 nights at 6 stations has been completed and all the train services have been fully restored from 6th November, 2023.

Shri Thakur further informed that the work involved land acquisition of private land as well as Government land (BMC). Further, 27 new FOBs have been constructed in lieu of existing FOBs which were inflicting the alignment. Contempt charge on man who defied HC stay, got UK divorce

Ahmedabad: A man from Kutch is facing the Gujarat high court's ire for pursuing the restitution of conjugal rights here while pursuing a divorce in a family court in the United Kingdom. He did the latter despite the HC having previously stayed the British court's divorce proceedings. Aashish Madhapaniya has been charged with contempt of court under Section 2 (c) of the Contempt of Court Act, 1971, by a bench led by Justice A J Shastri and Justice H M Prachhok. According to the case details, Madhapaniya was a resident of India, the origin who is a British citizen. Following matrimonial discord, the wife filed a divorce suit in a Bhuj court, while Madhapaniya demanded restitution of conjugal rights. The High Court of Bombay at Goa has issued a notice to the state government and Vasco police station in response to a petition filed by a parish priest seeking the quashing of an FIR against him under Section 9 of the Hindu Marriage Act. At the same time, the wife's divorce plea and the British court's order allowing Madhapaniya's plea for restitution of conjugal rights and directing her to fulfill her matrimonial duties. She also tried to reinstate her divorce suit. The husband defended the restitution of conjugal rights by filing an affidavit in the HC. However, at the same time, he filed a divorce petition in a family court at Willerden in the UK, said advocate Brijesh Trivedi, who represents the woman in this case. First time after demonetisation, Oct gold imports soar to 15.2 MT

Ahmedabad: For the first time in seven years after the demonetisation announcement, gold imports have touched 15.2 metric tonnes (MT) in Gujarat in October. The last time yellow metal imports surpassed this level was in November 2016, following the demonetisation announcement, when the imports touched 18.65 MT, indicates data by the Ahmedabad Air Cargo Complex (AAC). Gold prices have gone up from Rs. 59,100 per 10 grams in Ahmedabad on October 6 to Rs.63,000 on October 10 grams on Wednesday. The dip in gold prices came as a boon for jewellers and bullion traders as many stocked up gold anticipating high demand in the festive season. Explaining the trend, Hareesh Acharya, director, India Bullion and Jewellers' Association (IBJA) said, "Gold prices registered a sharp rise in owing to the escalated tensions between Israel and Gaza. However, when the yellow metal prices were low, jewellers and stockists procured gold in significant amounts anticipating an increased demand during festivities and the wedding season. Therefore, overall imports during October have increased." Ever since the customs-tariff integration has taken place on GIFT SEZ portal, jewellers are also able to import gold through the India International Bullion Exchange (IIBX) at GIFT City at 1% duty discount under the comprehensive economic partnership agreement (CEPA) between the India and the UAE. This has also propelled demand for gold according to industry players. Compared to October 2022, yellow metal imports have nearly doubled and gone up by 85% in a year, driven by more procurements of gold ahead of the festive season as prices dipped. "We saw good demand on Diwali and wedding merriments and the number of wedding merriments are significantly high. Therefore, we are anticipating good demand. Though exchange-based gold purchases are higher in proportion compared to purchase of new gold, the effective demand is expected to be high," said a city jeweller. The demand in India increased by 10% in the September period compared to the same period last year, according to the World Gold Council. The total demand for Q3 2023 was valued at Rs 1,88,400 crore, a 28% increase from the previous year. Jewelry demand was also up by 7% at 155.7 tonne. Investment demand for gold saw a significant increase of 20% at 54.5 tonne, driven by price correction and a positive economic sentiment. Gold prices have gone up from Rs. 58,100 per 10 grams in Ahmedabad on October 6 to Rs.63,000 per 10 grams on Wednesday. The dip in gold prices came as a boon for jewellers and bullion traders as many stocked up gold anticipating high demand in the festive season.

Sudden deaths: 'No autopsies planned'

Ahmedabad: Despite a string of sudden deaths among teens and youths in Gujarat, the state health department does not plan to carry out autopsies to understand its underlying cause. Dr R K Dixit, additional director of medical education in the state health department, confirmed this on Saturday. Dr Dixit was interacting with the media during a talk with senior cardiologists at the UN Mehta Institute of Cardiology and Research Centre (UNIMCRC) on Saturday to discuss the sudden death cases in the state and the apparent lack of connection with 'heart attack'.

Dr Dixit added that Gujarat-based cases are not part of the nationwide study by the UNIMCRC on sudden death cases. Medical Research. Earlier cardiologists said that against the popular notion of a rise in heart attack cases, the share of young patients at the hospital has remained the same during the Covid period. The UNIMCRC, one of the biggest cardiac super-specialty hospitals in India, has seen 12% of cases of heart attacks in 2023 compared to 8 to 11% in 2018-19. In private hospitals here, the share remained almost the same. Dr Chirag Doshi, director of UNIMCRC, said that all sudden death cases are not related to heart issues. Brain stroke, clotting in the lungs and other causes could also be the reasons.

Retired cop gets 4 years in jail for shooting at another ex-cop

Ahmedabad: A city sessions court on Saturday sentenced a retired police superintendent of duty, Brijesh Trivedi, to four years in jail for shooting at another retired cop and his friend from his licensed firearm near Parimal Garden in 2017.

Additional sessions judge H H Thakkar held Brijesh Trivedi guilty of attempted murder for opening fire at retired DSP Hardevsinh Zala and his friend Darshan Shah, after a quarrel with them on the evening of March 2, 2017, at Parimal Garden. Brijesh Trivedi was seen walking in the garden. Immediately after the quarrel, Rajvanshi went home on his motorcycle and returned with a 12-gauge shotgun and fired at Zala and his friend in the garden. Ellipsisridge police booked Rajvanshi for attempted murder, criminal intimidation and using abusive words. Prosecutor D P Padheriya produced 13 witnesses and examined 17 documents to establish Rajvanshi's guilt and sought exemplary punishment for him. The court did not accept the charges of criminal intimidation and use of abusive words and acquitted Rajvanshi.
