In continuation to our above referred letters, we would like to inform as under:

In the matter before hon'ble NCLAT on above referred case, in our letter dated 28.03.2024 it was informed that the next date of hearing was fixed for 02.05.2024. In this regard, it is stated that after the decision of hon'ble Delhi High Court on 05.04.2024 dismissing the appeal filed by CONCOR, by invoking limitation period for filing said appeal, against arbitration award the hon'ble NCLAT after hearing early hearing request by the operational creditor on 09.04.2024, preponed the hearing fixed in hon'ble NCLAT from 02.05.2024 to 16.04.2024. Further, after the above dismissal of appeal of the Company by hon'ble Delhi High Court, the Company has filed an appeal before the Division Bench of hon'ble Delhi High Court in which notice was issued on 10.04.2024. The copy of the order of Hon'ble NCLAT will be provided as soon as the same is made available to the Company.
