As intimated earlier the company has filed an application with the Securities and Exchange Board of India (SEBI) on 16th April, 2019, seeking relaxation of strict enforcement of Regulation 33 of SEBI LODR Regulations 2015 and extension of time for submission of Financial Results beyond the time prescribed under said Regulations.

1) A Criminal Complaint (FIR No.79/2019 dated 02-02-2019, Jubilee Hills Police Station, Hyderabad) was filed by Mrs. Dantapalli Hymavathi Reddy (Wo. Late Chandramohan Reddy), a shareholder belonging to the Promoter group of the Company against Mr. Dantapalli RohitReddy, Promoter Director, Mr.D.Vijaysen Reddy, Promoter of the Company and others.

- 2) Pursuant to the said Criminal Complaint, Police Department carried out Search and Seizure Operation (Vide Search Warrant Issued in Criminal M.P.No.503/2019 by the XVII Additional Chief Metropolitan Magistrate, Hyderabad) at various premises belongs to the Company and its Promoter Directors including Registered Office of the Company and Corporate Office of the Company, Registered office of its Subsidiaries and Associates and its Project Sites.
- 3) In said search and seizure operation Police Department ceased all electronic data of secretarial, finance and accounts related data of Prajay Engineers Syndicate Limited and its subsidiaries and associates namely Prajay Holdings Private Limited, Prajay Properties Private Limited, Prajay Land Capital Private Limited, Prajay Developers Private Limited which are very crucial and all back up CD's and hard disks servers and truck loads of physical records, documents and files were also seized and/or taken away by the Department. Further the bank accounts of above companies, other bank accounts relating to its promoter were also seized (Debit Freeze). The Company has intimated to the stock exchanges on 4th March, 2019 and 12th March, 2019 about the search and seizure operation done by Police Department.
- 4) In said search and seizure operation Police Department ceased all electronic data of secretarial, finance and accounts related data of Prajay Engineers Syndicate Limited and its subsidiaries and associates namely Prajay Holdings Private Limited, Prajay Properties Private Limited, Prajay Land Capital Private Limited, Prajay Developers Private Limited which are very crucial and all back up CD's and hard disks servers and truck loads of physical records, documents and files were also seized and/or taken away by the Department. Further the bank accounts of above companies, other bank accounts relating to its promoter were also seized (Debit Freeze).
- 5) The Company has already initiated appropriate legal remedies in this regard, a Writ Petition (WP No.5045/2019 and Quash Petition vide CRLP 1433/2019 (SR No. CRLPSR 1958/2019) were filed before the Hon'ble High Court for the state of Telangana, at Hyderabad to quash the Compliant and investigation in the aforesaid Criminal Compliant and for release and handover of the seized books, to permit to operate the respective bank accounts in the normal course, data and record of the Company and its subsidiaries.
- 6) Due to search and seizure operations, the Company left with Nil data all the back-ups were seized. In these circumstances it will be highly impossible and challenging for the Management and the Statutory Auditors of the Company and its Subsidiaries, to rebuild the data and to prepare accurate audited financial statements of the Company (both Standalone and Consolidated) and to submit and/or publish in terms of Regulation 33(3)(d) of SEBI (LODR) Regulations, 2015within the prescribed time period of 60 days from the quarter and financial year ended 31st March, 2019 i.e by May 30th, 2019.

Further the bank accounts of above companies, other bank accounts relating to its promoter were also seized (Debit Freeze). The management felt that it may cause a huge loss and may have a negative impact on the company as it is very much difficult and a time consuming task for the company to retrieve and rebuild its physical and electronic data at the close of the FY 2018-19.

The management further felt that present situation may also have an impact on the day to day administration (as the company stood with "Nil" electronic data (finance, accounts and secretarial) and the company may be unable to conduct statutory compliances such as conducting the statutory audit and declaration of financial results within prescribed timelines, as it is very much difficult to rebuild the physical and electronic data (running and stock data) unless the data and documents seized were handed over back to the company. However, the management has already initiated the process of taking the appropriate measures and necessary remedial actions to manage this crisis and further management have the confidence that it will be able to eliminate the disruption associated with the search and seizure and will be able to place the company in the best legal position.

We further like to inform you that the search and seizer was carried out based on the compliant given by Mrs. D. Hymavathi Reddy shareholder, promoter group and relative of promoter who has already approached NCLT, NCLAT and High Court with the same allegations.

Brief Facts of the Case:-

- The petitioners are seeking quashment of the complaint and investigation in F.I.R.No.79 of 2019 of Jubilee Hills Police Station since the petitioners herein are falsely implicated for the alleged offences under Section 420, 467, 468, 471, 409, 120B of IPC in as much as the said complaint and investigation is an abuse of process of law.
- It is submitted that the 2nd respondent herein is the de facto complainant. She has instituted cases under the Companies Act, 2013 before the National Company Law Tribunal in C.P.No.119 of 2018 with regard to the affairs of Prajay

Engineer Syndicate Limited and its group companies alleging that there is an operation—and mismanagement of the minority shareholders by the majority shareholders who are the petitioners herein. It is submitted that the matter is pending before the said statutory tribunal.

The 2nd respondent has given a compliant to the 1st respondent police on 02.02.2019 which is consisting of certain allegations/events relating to the years 2014, 2017 and 2018 which are similar and identical to the allegations contained in the above said company law matter and made a prayer to the police to register criminal case against the petitioners herein. A perusal of the compliant would show that there is no specific allegation that the petitioners herein have committed any criminal offence. Surprisingly in the said crime, the police have obtained an order from the court of Magistrate for issuance of a search warrant exparte and the said search warrant was enforced on 02.03.2019 and various books and records of the group companies were seized. It is submitted that Section 94 and Section 165 of Cr.P.C. do not authorize the police to conduct seizure of the books and records or for that matter any other incriminating material. Thus the de facto complainant has successfully prevailed upon the police and got the records of the company seized and kept at the disposal of the police. An inventory was prepared by the police and copy has been furnished to the petitioners which is filed along with this petition and since large number of books and records which are totally unconnected with the complaint of the 2nd respondent are seized by the police, the petitioners are unable to run the companies and the de facto complainant has successfully stalled the activities of the group companies. Since the complaint is not disclosing commission of any criminal offence, the same is liable to be guashed as per the law laid down by the Supreme Court in 1982 (1) SCC 561 para 21 and 65. Further the police have seized the books and records of the group companies without any authority of law and in violation of Sections 165 of the Cr.P.C. and hence the Honourable Court may direct the police to forthwith return the seized record to the petitioners. It is settled law that a compliant or a charge sheet is liable to be quashed when the allegations contained therein are either vague or inherently improbable. A perusal of the compliant of the 2nd respondent would disclose that it is vaque, general and without any specific allegations directed against any named person. Such complaints should be quashed since the parties cannot take recourse to criminal law in respect of civil disputes (2006 (6) SCC 736 para 12 and 13). Request for Relaxation of strict enforcement of Regulation 33 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI (LODR) Regulations, 2015 - Request for extension of time for filling Audited Financial Results (both Standalone and Consolidated) for the quarter and financial year ended 31st March, 2019 beyond the time prescribed under Regulation 33(3)(d) of SEBI (LODR) Regulation, 2015.

With reference to above subject we humbly submit the following:

1. **BACK GROUND:**

Prajay Engineers Syndicate Limited ("PESL" is a Company incorporated under 1.1 Companies Act, 1956, with CIN L45200TG1994PLC017384, having its registered Office at 1-10-63 & 64, 5th Floor, Prajay Corporate House, Chikoti Gardens, Begumpet, Hyderabad -500016, Telangana, India. Prajay Engineers Syndicate Limited ("The Company") is Listed in both BSE Limited (with Scrip Code: 531746) and National Stock Exchange India Limited (with Symbol PRAENG) with Listed Rs.69,93,57,910 /- comprising 6,99,35,791 Equity Shares of Rs/.10/- each. The Company is primarily engaged in Real Estate activities, Construction and Development and Hospitality Services.

2. REASONS FOR SEEKING RELAXATION

- 2.1 Recently a Criminal Complaint (FIR No.79/2019 dated 02-02-2019, Jubilee Hills Police Station, Hyderabad) was filed by Mrs. Dantapalli Hymavathi Reddy (W/o. Late Chandramohan Reddy), a shareholder belonging to the Promoter group of the Companyagainst Mr. DantapalliRohitReddy, Promoter Director, Mr.D.Vijaysen Reddy, Promoter of the Company and others.
- 2.3 Pursuant to the said Criminal Complaint, Police Department carried out Search and Seizure Operation (Vide Search Warrant Issued in Criminal M.P.No.503/2019 by the XVII Additional Chief Metropolitan Magistrate, Hyderabad) at various premises belongs to the Company and its Promoter Directors including Registered Office of the Company and Corporate Office of the Company, Registered office of its Subsidiaries and Associates, Project Sites. Copy of Search Warrant is enclosed as Annexure –I to this Application

- 2.4 In said search and seizure operation Police Department ceased all electronic data of secretarial, finance and accounts related data of Prajay Engineers Syndicate Limited and its subsidiaries and associates namely Prajay Holdings Private Limited, Prajay Properties Private Limited, Prajay Land Capital Private Limited, Prajay Developers Private Limited which are very crucial and all back up CD's and hard disks servers and truck loads of physical records, documents and files were also seized and/or taken away by the Department. Further the bank accounts of above companies, other bank accounts relating to its promoter were also seized (Debit Freeze). The Company has intimated to the stock exchanges on 4th March, 2019 and 12th March, 2019 about the search and seizure operation done by Police Department. The Copies of intimations given to Stock Exchanges were enclosed as Annexure II to this Application.
- 2.5 The Company has already initiated appropriate legal remedies in this regard, a Writ Petition (WP No.5045/2019) was filed beforethe Hon'ble High Court for the state of Telangana, at Hyderabadto quash the Compliant and investigation in the aforesaid Criminal Compliant and for release and handover of the seized books, to permit to operate the respective bank accounts in the normal course, data and record of the Company and its subsidiaries. The said WP No.5045/2019 is still pending before the Hon'ble High Court. The copies of rit Petition and other Petitions filed by the Company along with the case status is enclosed herewith as Annexure III to this Application.
- 2.6. Due to search and seizure operations, the Company left with Nil data all the back-ups were seized. In these circumstances it will be highly impossible and challenging for the Management and the Statutory Auditors of the Company and its Subsidiaries, to rebuild the data and to prepare accurate audited financial statements of the Company (bothStandalone and Consolidated) and to submit and/or publish in terms of Regulation 33(3)(d) of SEBI (LODR) Regulations, 2015within the prescribed time period of 60 days from the quarter and financial year ended 31st March, 2019 i.e by May 30th, 2019. However, the Company is putting its complete efforts to bring back the documents as early as possible.

In view of the above situation, the Company is requesting to seek extension of time for filing results for the quarter and financial year ended 31st March, 2019 beyond the time prescribed under Regulation 33(3)(d) of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015

Further under Regulation 101 of the SEBI (LODR) Regulations, 2015 SEBI is empowered to issue clarification through guidance notes or circular after recording reasons in writing in order to remove any difficulties in the application or interpretation of the Listing Regulations.
