The Company received 75% amount of the warrant exercise price i.e., Rs. 16.17/- (75% of Rs.21.57) per warrant from 7 warrant holders and allotted them 62,50,000 equity shares on October 03, 2023 and from 10 warrant holders and allotted them 3,46,75,000 equity shares on November 07, 2023 upon conversion of warrant. The total amount received for utilization in the reported quarter is Rs.66.18 crore. Hence, the total amount received till the quarter ended December 31, 2023 is Rs. 124.90 crore.
