- 1. We have reviewed the accompanying Statement of Unaudited Standalone Financial Results of SEYA INDUSTRIES LTD. ("the Company"), for the Quarter and Nine Months ended December 31, 2023("the Statement"), being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("Listing Regulations")
- 2. This Statement which is the responsibility of the Company's Management has been approved by the Independent Committee and IRP, has been prepared in accordance with the recognition and measurement principles laid down in the Indian Accounting Standard 34 "Interim Financial Reporting" ("Ind AS 34"), prescribed under section 133 of the Companies Act, 2013 read with the relevant rules issued there under and other accounting principles generally accepted in India. #### Note to the unaudited standalone financial statements for the quarter and Nine Months ended December 31, 2023

Pursuant to the Order dtd November 2, 2023, passed by Hon'ble National Company Law Tribunal, Mumbai ("NCLT" Corporate Insolvency Resolution Process is initiated against the Company.

The above financial results for the Quarter and Nine Months ended December 31, 2023 have been reviewed by the Independent Committee constituted by IRP and approved by the IRP in their meeting held on February 14, 2024 and are as per Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. The said results have been prepared in accordance with Indian Accounting Standards(Ind AS) prescribed under section 133 of the Companies Act, 2013, read with the relevant rules and provisions of Companies Rules, 2015 and Companies Act, 2013(as amended from time to time). The financial results and other financial information pertaining to each of the quarters have not been audited by the statutory auditors. However, the management of the Company has exercised necessary due diligence to ensure that the standalone unaudited financial results provide a true and fair view of the Company's affairs.

The Company has only one reportable segment namely 'Speciality Chemical Intermediates'.

Due to ongoing dispute with the certain lenders in relation to their failure to comply with committed lending obligations and outstanding, the Company has not provided for interest costs on certain loans outstanding, amounting to INR 592.55 Lacs in respect of Operating Assets and INR 1684.70 Lacs in respect of Project Assets, for the Quarter ended Dec 31, 2023. The Company continues to believe in the merits of the litigation, however, there continues to remain material uncertainties in relation to the outcome of the said litigations.

Prior period figures have been regrouped/rearranged/re-classified wherever considered necessary for comparison purpose and as per present period classification
