Several agencies, including the Enforcement Directorate, have been investigating the matter, while also summoning several Bollywood celebrities for questioning in the case. In the case lodged at Matunga, the complainant has alleged that citizens are being manipulated and cheated, while also being encouraged to bet through various games like cricket, tennis, teen-patti, football and so on, enabling the app promoters to make wrongful gains.
