Pursuant to Regulation 30(6) read with Schedule III and other applicable provisions of the SEBI Listing Regulations, we hereby inform you that basis recommendations of the Nomination and Remuneration Committee, the Board of Directors of the Company has at their meeting held today, i.e. Monday, 22 April 2024, *inter alia*, approved the re-appointment of Mr. Rampraveen Swaminathan (DIN: 01300682) as the Managing Director & Chief Executive Officer ("CEO") of the Company, liable to retire by rotation, for a period of 5 (five) years with effect from 4 February 2025 to 3 February 2030 (both days inclusive), subject to approval of the shareholders of the Company at the ensuing 17th Annual General Meeting of the Company.

Details with respect to re-appointment of Mr. Rampraveen Swaminathan as the Managing Director & CEO of the Company, as required under Regulation 30(6) read with Para A(7) of Part A of Schedule III of the SEBI Listing Regulations and SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated 13 July 2023 are provided in Annexure I to this letter.

Further, the Board of Directors of the Company has, basis the recommendations of the Nomination and Remuneration Committee, decided not to proceed with the variation in terms of remuneration of Mr. Rampraveen Swaminathan, Managing Director & CEO of the Company, which was earlier approved by the Board of Directors at its meeting held on 30 August 2023 subject to approval of the shareholders through Postal Ballot, for the remainder period of his current tenure of appointment i.e. up to 3 February 2025.

The Meeting of the Board of Directors of the Company commenced at 2:34 p.m. (IST) and concluded at 5:31 p.m. (IST).
