  - Pursuant to the Scheme of Arrangement and approval of change of name by the Registrar of Companies, Coimbatore vide Certificate of Incorporation pursuant to change of name dated 27<sup>th</sup> July 2023, the name of the Company has been changed from 'Revathi Equipment Limited' to 'Semac Consultants Limited' and the new name has been reflected in BSE Limited and the National Stock Exchange of India Limited (stock exchanges where the Company shares are listed).
  - As per the Composite Scheme of Arrangement, the shares held by Renaissance Advanced Consultancy Limited (RACL) and Renaissance Stocks Limited (RSL) have been cancelled. Consequently, the capital of the Company has been reduced from 30,66,943 to 8,40,990, which is not reflected in both the depositories (NSDL & CDSL). Further, the Company is yet to allot shares to the shareholders of Renaissance Advanced Consultancy Limited (RACL) and Semac Consultants Private Limited (SCPL).
  - The Company has kept 609 shares in "Investor Education and Protection Fund" in accordance with the provisions of Section 124(6) of the Companies Act, 2013 and rules made thereunder. The voting rights in respect of these shares have been frozen till the rightful owner claims the same.
