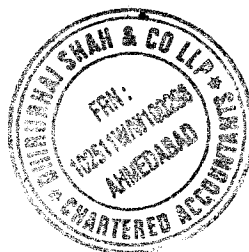

- The Company operates two reportable segments, i.e. PVC Film Sheeting / Aluminium Foil.


