He is a Fellow of the Institution of Engineers, India and a certified Chartered Engineer.

He was responsible for building the Missiles Business for the Adani Group and won several contracts from DRDO and Indian customers.

Some of the key achievements in his career include successfully concluding large contracts with the DRDO, Indian Army, Indian Air Force, Indian Navy and Dassault Aviation, France, for the supply of Falcon 2000 Business Jet Cockpits, Fuel Tanks, and Rafale Engine Bay Doors.
