In historic vote, Speaker Kevin McCarthy ousted

The US House of Congress was plunged into chaos, confusion and paralysis on Tuesday after Speaker Kevin McCarthy was ousted in a historic rebellion by far-right Republican rebels who were furious at his cooperation with Democrats to avert a shutdown by extending federal funding through mid-November.

After the vote to remove McCarthy, lawmakers quickly left Washington as Republicans remained deeply divided over who could lead their fractious majority. "The office of speaker of the House of the United States House of Representatives is hereby declared vacant," Representative Steve Womack, Republican of Arkansas, a McCarthy ally who presided over the chamber during the vote, declared after banging the gavel to finalize the result. Soon after, McCarthy told Republicans that he would not seek to reclaim the post, ending a tumultuous nine months as speaker. "It is my responsibility (to save the gov't from a shutdown). It is my job. I do not regret negotiating; our government is designed to find compromise," McCarthy said.

McCarthy accused his far-right Republican rebels of wanting to "burn the whole place down" - an eloquent commentary on his party. His political assassins, led by Florida Rep. Matt Gaetz, topped their leader with no plan for what comes next. The brutal move to axe McCarthy exposed the chaotic levels of infighting among Republicans heading to the 2024 presidential election. Gaetz and his band of rebels were warned by their leadership about plunging the party "into chaos."

But Gaetz retorted, "Chaos is Speaker McCarthy. Chaos is somebody who we cannot trust with their word." The New Democrat Coalition, a bloc of pro-business Democratic lawmakers, described McCarthy as "simply not trustworthy." Said CNN in an analysis, "The self-inflicted chaos will hamper the Republican party's effort to capitalise on President Joe Biden's vulnerability, and the fresh show of incompetence and extremism could

hamper the GOP's bid to retain swing seats it needs to keep its majority next year. More importantly Tuesday's political regicide showed that the majority in the House is inoperable and that the Republican Party is unmanageable. Until that changes, America itself will be ungovernable." Representative Patrick T. McHenry of North Carolina was named as interim House speaker, but he does not have power to run the chamber - only to preside over the election of a new speaker.

New York judge issues gag order on Trump

Donald Trump got an ear-full from Judge Arthur Engoron who is presiding over a civil fraud case against the former US president for attacking his clerk in a social media post Tuesday and issued a gag order that forbade the parties from making any future comments about his staff. Before the second day of the trial commenced, Trump posted on Truth Social attacking Engoron's clerk, claiming she was a "girlfriend" to Senate Majority Leader Chuck Schumer, a New York Democrat, and showing a picture of the two of them together.

"How disgraceful!" Trump wrote. "This case should be dismissed immediately." "And this rogue judge, a

Trump hater. The only one that hates Trump more is his associate up there," Trump said. "The person that works with him. She's screaming into his ear almost every time we ask a question. A disgrace. It's a disgrace."

It was not immediately clear if there was a connection between Engoron's clerk and Schumer beyond taking a photo. This angered Judge Engoron who said, "This morning one of the defendants posted on (a) social media account a disparaging untrue and personally identifying post about a member of my staff. Although I have since ordered the post deleted and apparently it was, it was also emailed out to millions of other recipients. Personal attacks of any member of my court staff are not acceptable, inappropriate and I will not

tolerate them," the judge said. "Trump looked straight ahead at the judge as he issued the order. The judge then said all parties must not speak publicly about any members of the court staff."

"Consider this statement an order forbidding all parties from posting, emailing or speaking publicly about any members of my staff," Engoron said. "Failure to abide by this... will result in serious sanctions."

The New York attorney general is seeking to bar Trump from doing business in the state. Last week, the judge ruled that Trump and his co-defendants were liable for "persistent and repeated" fraud, one of seven claims the attorney general is trying to prove.
