Sub: Intimation under Regulation 30 of SEBI LODR Regulations, 2015 – Temporary shutdown

Dear Sir/Madam,

In continuation of the intimation vide our letter dated April 3, 2024 we would like to inform you that, the operations of the Manufacturing plant situated at Kadiyam Unit, East Godavari has been temporarily shut down on April 15, 2024 owing to non-availability of pulp from manufacturing unit at Rajahmundry where the illegal strike by workmen called by the workers unions is continuing since April 2, 2024. The Kadiyam unit will resume operations as soon the pulp supply is restored.

The Company Management is in discussion with the Trade Unions at Rajahmundry and the local authorities to resolve the issue amicably as soon as possible and shall provide update on further developments in due course.

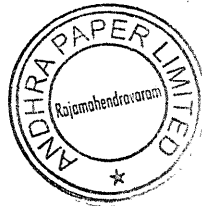

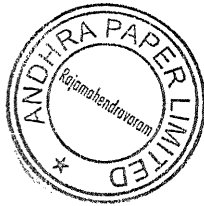
