I, Chandanbala O. Mehta, a Practicing Company Secretary having office at No. 3, 1st Floor, 20/24 Morarji Velji Bldg., Dr. M.B. The management of the company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and Rules relating to postal ballot and e-voting on the resolutions contained in the notice of postal ballot. In this regard, I submit herewith my Report as under:

- 1. The company had provided facility of casting vote to the members of the company through the process of remote e-voting only in compliance with the MCA General Circulars.
- 2. MCA vide its General Circulars, has permitted to conduct the Postal Ballot by sending the Notice in electronic form only. Accordingly, physical copy of the Notice along with Postal Ballot Form and pre-paid business reply envelope were not sent to the Members for this Postal Ballot. The communication of the assent or dissent of the Members would take place through the process of remote e-voting only.
- 3. The company has published on December 05, 2023, an advertisement about the dispatch of Postal Ballot Notice in The Free Press Journal (English) and Navshakti (Marathi).
- 4. The members of the company whose names were recorded in the Register of Members or in the Register of Beneficial Owners maintained in the Depositories as on the "Cut-off" date i.e. November 24, 2023 were entitled to vote electronically, in respect of the resolution as set out in the Postal Ballot Notice only through the remote e-voting.
- 5. The e-voting period remained open from Wednesday, December 06, 2023 (9:00 AM) to Thursday, January 04, 2024 (5:00 PM).
- 6. After the closure of voting period on January 04, 2024, I have unblocked the electronic votes on January 04, 2024 at 05:10 p.m. in the presence of two witnesses Ms. Harshida Parikh and Mrs. Deepika Purohit, not in the employment of the Company.
- 7. The details containing the list of the shareholders who casted their vote electronically for the Resolutions was downloaded from the e-voting website of Central Depository Services (India) Limited.
- I have scrutinized and counted the votes casted through e-voting facility and their particulars have been recorded in accordance with the Companies (Management and Administration) Rules, 2014.
