Sub:- Clarification / Confirmation on news item appearing in "Media Publication"


Dear Sir,

We refer to the NSE Letter no. We also refer to our Clarification Letter October 9, 2023 giving clarification of the news item published in Economic Times of same date, wherein the said article had clearly stated in "none of the listed JSW Group entities will be involved in the deal."


