

INDEPENDENT AUDITOR'S REPORT

The Board of Directors of
Alka Securities Limited

1. We have audited the accompanying Statement of Standalone Financial Results of Alka Securities Limited ("the Company") for the year ended March 31, 2018 ("the Statement"), being submitted by the company pursuant to the requirement of Regulation 52 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with Circular No. CIR/IMD/DFI/69/2016 dated August 10, 2016.

This statement, which is the responsibility of the Company's Management and approved by the Board of Directors, has been prepared on the basis of the related Standalone Audited Financial Statement which have been prepared in accordance with the Indian Accounting Standards prescribed under Section 133 of the Companies Act, 2013 read with relevant rules issued thereunder ("Ind AS") and other accounting principles accepted in India. 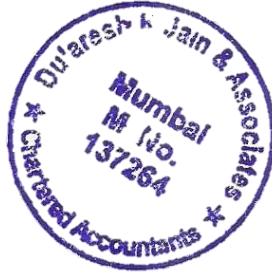
