INDEPENDENT AUDITOR'S REVIEW REPORT ON REVIEW OF INTERIM STANDALONE FINANCIAL RESULTS

To The Board of Directors Galada Finance Limited

- We have reviewed the accompanying statement of unaudited standalone financial results of M/s.
