In compliance with Regulation 30 and other applicable provisions of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements), Regulations, 2015 ("SEBI Listing Regulations"), it is hereby informed that the Company has decided to disinvest its investment of Rs. 1,00,000/- made in M/s. Arvog Enterprises Limited (CIN: U82990MH2023PLC412647), a wholly owned subsidiary (WOS) of M/s. Finkurve Financial Services Limited which was incorporated on October 20, 2023

The Company had incorporated M/s. Arvog Enterprises Limited for carrying out a specific business, in line with its existing business. However, due to certain reasons, the Company could not start the said business operations in the WOS and also no longer intends to pursue the said purpose for which WOS was incorporated and therefore has decided to disinvest its entire investment from M/s. Arvog Enterprises Limited. Further, it may be noted that it is not a Material Subsidiary of the Company. and that such disinvestment shall not affect the revenue or business of the Company.
