Postal Ballot - JK Agri Genetics Limited

I, CS P.K. Sarawagi of M/s. P. Sarawagi & Associates, Company Secretaries, had been appointed as Scrutinizer for the purpose of scrutinizing the Postal Ballot Process conducted through Electronic Voting (e-voting), in a fair and transparent manner and ascertaining the result thereof, in respect of the resolutions transacted through Postal Ballot process, for seeking approval of the Members of JK Agri Genetics Limited, for appointment of Shri Kuldeep Kumar Pandit (DIN:08381208) as (1) a Director of the Company, liable to retire by rotation, and (2) a Whole-time Director of the Company with the designation 'President & Director' for a period of three years w.e.f. 24th November 2023, as detailed in the Postal Ballot Notice dated 19th December 2023.

In compliance with the provisions of Sections 108 & 110 of the Companies Act, 2013 ("the Act") read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014 and the General Circulars No. 14/2020, No. 17/2020, No. 22/2020, No. 33/2020, No. 39/2020, No. 10/2021, No. 20/2021, No. 03/2022, No. 11/2022 and No. 09/2023 dated 8th April 2020, 13th April 2020, 15th June 2020, 28th September 2020, 31st December 2020, 23th December 2021, 8th December 2021, 5th May 2022, 28th December 2022 and 25th September, 2023, respectively, issued by the Ministry of Corporate Affairs (hereinafter, collectively referred to as the "MCA Circulars") and Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (SEBI LODR Regulations), the Company had sent the Postal Ballot Notice dated 19th December 2023 through e-mail on 21st December 2023 to all those Members whose names appeared in the Register of Members/List of Beneficial Owners as received from National Securities Depository Limited ("NSDL") and Central Depository Services (India) Limited ("CDSL") as on 15th December 2023 ("cut-off date") and provided the facility of voting through electronic means.

Compliances of the provisions of the Companies Act, 2013, the Rules framed thereunder, the MCA Circulars and the SEBI LODR Regulations, relating to voting through electronic means on the Postal Ballot by the Members of the Company on the Resolutions contained in the Postal Ballot Notice dated 19th December 2023, are responsibility of the Management of the Company. My responsibility as Scrutinizer is to ensure that electronic voting process is conducted in a fair and transparent manner and to make a Scrutinizer's Report, being this Report, of the total votes cast 'in favour' and 'against', the Resolutions as set out in the Postal Ballot Notice, based on report generated from the e-Voting system provided by the Central Depository Services (India) Limited (CDSL).

I submit my report as under:

- The Company has appointed CDSL as the agency to provide and facilitate e-voting services to the Members of the Company to cast their votes through a secured electronic voting system on the Resolutions to be transacted through Postal Ballot.
- 2. In terms of requirements of the MCA Circulars, the Postal Ballot Notice dated 19th December 2023, was sent through electronic means on 21st December 2023 to those Members whose e-mails were registered with the Company/the Company's Share Transfer Agent (RTA)/ Depositories, as on 15th December 2023. The Postal Ballot Notice was also placed on the website of the Company, BSE Limited and CDSL at www.jkagri.com, www.bseindia.com and www.evotingindia.com, respectively.
- 3. The e-voting period remained open from 10:00 a.m. on 22nd December 2023 till 5:00 p.m. on 20th January 2024. The Members holding shares as on the 'cut-off' date i.e. 15th December 2023, were entitled to vote, through e-voting system, on the proposed resolutions as set out in the Postal Ballot Notice dated 19th December 2023.
- 4. The requisite advertisement pursuant to Sections 108 & 110 of the Companies Act, 2013 read with Rules 20 & 22 of the Companies (Management and Administration) Rules, 2014, was published in the "Financial Express" (all editions), in English language and in "Aajkaal" (Kolkata edition) in Bengali language, on 22nd December 2023.
- 5. The votes cast by the Members through the e-voting system provided by CDSL were unblocked by me on 20th January 2024 at 17:55 p.m., in presence of two witnesses, namely, (1) Mr. Vineet Singh and (2) Mrs. Sushma Poddar, both of M/s. P. Sarawagi & Associates.
- The votes cast were diligently scrutinized and authenticated based on the records maintained by the Company and its RTA, with respect to number of shares held on 'cut-off' date i.e., 15th December 2023 and authorisation lodged for the purpose.
- 7. Based on the details contained in the list of Members who have cast their votes through e-voting system as downloaded from the e-voting website of the CDSL (www.evotingindia.com), the results of e-voting on the business transacted through Postal Ballot, are given below:
