जब हम अधिकार के मामले में समानता की अपेक्षा रखते है तो कानून के मामले में भी समानता के लिए समान नागरिक संहिता ही बराबरी देगी।



लोकजीवन

समान नागरिक संहिता...

एक देश एक कानून की परिकल्पना आकार लेती नजर आ रही है। हालांकि समान नागरिक संहिता का मामला दशकों से मात्र विचार तक ही सीमित रहता आया है। जिसकी सबसे बडी वजह यह है कि अलग-अलग धार्मिक प्रथा तथा परम्पराएं। जिन्हें लेकर सदैव यह आशंका व्यक्त की जाती है कि समान नागरिक संहिता किसी धर्म विशेष पर थोपने की कोशिश है या यूं कहेंयह आशंका रहती है कि उन्हें कानूनन बाध्य किया जाएगा कि अपनी परम्परागत रस्मों से हटकर समान व्यवहार के लिए तैयार रहे। साठ के दशक से ही इस विषय पर चिंतन मंथन जारी है लेकिन अभी तक इसे धार्मिक नजरिए से ही देखा जाता रहा । मोदी सरकार ने अपने दो कार्यकाल में विशेष उपलब्धियां हासिल की | जिनमें धारा-370 व 35-ए हटाना एवं राम मंदिर निर्माण भाजपा का मुख्य मुद्दा रहा था। वहीं उम्मीद तो यह जताई जा रही थी कि इसी सत्र में समान नागरिक संहिता पर भी कदम बढायेगी। लेकिन केन्द्र ने न ही बल्कि भाजपा शासित राज्य उत्तराखंड ने इसकी पहल कर दी है और विधानसभा में पारित होने के साथ ही उतराखण्ड देश का पहला राज्य बन गया है जहां समान नागरिक संहिता लागू होने जा रही । वहीं राजस्थान सहित कई अन्य राज्य तैयारी कि वहां भी समान नागरिक संहिता लागू हो। ऐसा होने से केन्द्र को और भी आसानी हो जाएगी और एक देश एक कानून का संकलप पूरा होता नजर आएगा।

उत्तराखण्ड विधानसभा ने सर्वसम्मति से देश का पहला समान नागरिक संहिता (यूसीसी) विधेयक ध्वनिमत से पारित कर दिया। बिल पास होने पर मुख्यमंत्री पुष्करसिंह धामी ने कहा कि मैं प्रधानमंत्री नरेन्द्र मोदी का भी धन्यवाद करना चाहता हूं कि उनकी प्रेरणा और मार्ग दर्शन में हमें यह विधेयक पारित करने का मौका मिला। कानून के बारे में अलग-अलग लोग अलग-अलग बातें कर रहे है लेकिन सभी बातें विधानसभा की चर्चा में स्पष्ट हो गई। ये कानून हम किसी के खिलाफ नहीं लागये है ये कानून बच्चों और मातृशक्ति के भी हित में है। विधेयक नहीं लागये है ये कानून बच्चों और मातृशक्ति के भी हित में है। विधेयक में शादी, तलाक, विरासत और गोद लेने से जुड़े मामलों को ही शामिल किया गया है। खास तौर पर विवाह प्रक्रिया को लेकर जो प्रावधान बनाये गये है उनमें जाति धर्म या पंथ की परम्पराओं और रीति रिवाजों से कोई छेड़छाड़ नहीं की गई है । वैवाहिक प्रक्रिया में धार्मिक मान्यताओं पर कोई फर्क नहीं पड़ेगा। धार्मिक रीति रिवाज जस के तस रहेंगे ऐसा भी नहीं कि शादी पंडित या मौलवी नहीं करायेंगे। खानपान, पूजा इबादत, वेशभूषा पर भी इसका कोई प्रभाव नहीं पड़ेगा। विधेयक में द्वि विवाह या बहु विवाह की प्रथाओं को जैर कानूनी घोषित किया गया है। यह एक शर्त के साथ किया जा सकता है कि किसी भी पक्ष के पास विवाह के समय जीवित जीवन साथी न हो। आज आवश्यकता इस बात की है कि अन्य राज्य भी निष्पक्ष भाव से महिला बच्चों के हितों को ध्यान में रखते हुए समान नागरिक संहिता लागू करने की पहल करें।

राजस्थान में मतदाताओं की संख्या 5 करोड़ से अधिक 15 लाख से ज्यादा नए मतदाता करेंगे मतदान

लोकजीवन न्यूज नेटवर्क, जयपुर राजस्थान निर्वाचन विभाग ने मतदाता सूचियों का अंतिम प्रकाशन किया। प्रदेश में कुल मतदाताओं के संख्या पांच करोड़ 32 लाख से अधिक हुई। वहीं, 15 लाख 54 हजार से अधिक नव मतदाता पहली बार मतदान करेंगे।

प्रदेश के सभी जिलों में निर्वाचन विभाग द्वारा गुरुवार को राज्य के 199 विधानसभा निर्वाचन क्षेत्रों की एकीकृत फोटो युक्त मतदाता सूचियों का अंतिम प्रकाशन किया गया। करणपुर विधानसभा क्षेत्र की सूचियों का अंतिम प्रकाशन 13 फरवरी को होगा।

मुख्य निर्वाचन अधिकारी प्रवीण गुप्ता ने बताया कि लोकसभा आम चुनाव 2024 के लिए प्रदेश में कल पांच करो? 32 लाख से अधिक मतदाता पंजीकृत हैं (करणपुर विधानसभा क्षेत्र के आंकडों सहित)। 199 विधानसभा निर्वाचन क्षेत्रों की प्रकाशित अंतिम मतदाता सूचियों में कुल 5,29,68,476 मतदाता हैं। इनमें से 2,74,75,971 पुरुष और 2,53,51,276 महिला एवं 1.41.229 सेवा नियोजित मतदाता सम्मिलित हैं। उन्होंने बताया कि 18-19 साल के 15,54,604 नव मतदाता वर्ष 2023 में संपन्न विधानसभा आम चुनाव के बाद जोड़े गए हैं, जो आगामी चुनाव में पहली बार मताधिकार का प्रयोग करेंगे। इन सूचियों में थर्ड जेंडर के 616 मतदाता पंजीकृत हैं। गुप्ता ने बताया कि विधानसभा चुनाव 2023 के बाद मतदाता सूचियों में शुद्ध रूप से 2,79,366 मतदाताओं की वृद्धि हुई है। जबकि प्रारूप प्रकाशन के बाद संक्षिप्त पुनरीक्षण कार्यऋम-2024 के दौरान 5,20,807 मतदाताओं की वृद्धि हुई है। इस अवधि में 2,64,564 मतदाताओं के नाम विलोपित भी किए गए हैं। इस प्रकार शुद्ध रूप से 2,56,243 मतदाताओं की वृद्धि हुई है।



राजनैतिक दलों के प्रतिनिधियों के साथ बैठक

गुमा ने बताया कि एकीकृत मतदाता सूचियों के संबंध में गुरुवार को राजनैतिक दलों के प्रतिनिधियों के साथ बैठक में जानकारी दी गई हैं। सभी राजनैतिक दलों से बीएलए नियुक्त करने का आह्वान किया गया है। समस्त मान्यता प्राप्त राजनैतिक दलों की बैठक आयोजित कर मतदाता सूचियों की हार्ड एवं सॉफ्ट कॉपी निषुत्क प्रदान करने के संबंध में जिला निर्वाचन अधिकारियों को निर्देश दिए गए हैं। गुप्ता ने बताया कि 7 जनवरी एवं 21 जनवरी को राज्य के सभी मतदान केन्द्रों पर आयोजित विष्ठेष अभियान शिविरों में मतदाताओं के पंजीकरण के लिए महिला खयं सहायता समूहों द्वारा स[ि] य सहयोग किया गया।

बैठक में गुप्ता ने बताया कि भारत निर्वाचन आयोग के निर्देशों के क्रम में लोकसभा आम चुनाव हेतु ईवीएम वीवीपीएटी मशीनों की प्रथम स्तरीय जांच का कार्य भारत इलेक्ट्रॉनिक लिमिटेड, बेंगलुरु के 276 इंजीनीयर्स द्वारा 27 जनवरी 2024 से राज्य के सभी जिलों में प्रारंभ किया गया है। उन्होंने बताया कि मशीनों की प्रथम स्तरीय जांच का कार्य 16 फरवरी 2024 तक पूर्ण होने की संभावना हैं। सात फरवरी तक 65 प्रतिशत कार्य पूर्ण हो चुका है। ईवीएम से तात्पर्य बैलेट यूनिट (बीयू), कंट्रोल यूनिट (सीयू) और वीवीपीएटी से हैं। राज्य के जिलों में लाइव वेब कास्टिंग के जरिए लगभग 90,689 बीयू, 73,005 सीयू और 73,005 वीवीपीएटी मशीनों की जांच करवाई जा रही है। एफएलसी ओके मशीनों को ईवीएम डेमोस्ट्रेशन सेंटर पर आमजन के लिए वोट प्रा

सबसे अधिक और कम मतदाता इन विधानसभा क्षेत्रों में

सबसे ज्याबा झोटवाड़ा विधानभा क्षेत्र में 4,37,479, बगरू में 3,60,013, सांगानेर में 3,59,012, विद्याधरनगर में 3,50,638, लूणी में 3,38,187 मतदाता पंजीकृत हैं। सबसे कम मतदाता किशनपोल विधानसभा क्षेत्र में 1,94,902 मतदाता, जोधपुर में 1,99,809, बसेड़ी में 2,04,021, पीपत्दा में 2,10,146 अजमेर उत्तर में 2,10,244 मतदाता पंजीकृत हैं। झोटवाड़ा विधानसभा क्षेत्र में सबसे अधिक 2,10,464 महिला मतदाता पंजीकृत हैं। जबकि सबसे कम महिला मतदाता बसेड़ी में 93,096 में पंजीकृत हैं।

दिव्यांग एवं बुजुर्ग मतदाताओं की संख्या बढ़ी

शुमा ने यह भी बताया कि 19 जनवरी को मतदान केन्द्र स्थलों पर दिव्यांग मतदाताओं के पंजीकरण के लिए विशेष शिविर आयोजित हुए। विधानसभा चुनाव 2023 के दौरान प्रदेश में 5 लाख 60 हजार 425 दिव्यांग मतदाता तथा 80 वर्ष से अधिक आयु के 11 लाख 72 हजार 260 पंजीकृत थे, जिनकी संख्या अब बढ़कर मशः 5,72,965 तथा 12,85,960 हो गई है।

लैंगिक अनुपात में सुधार हुआ

मतदाता सूचियों के अंतिम प्रकाशन 08.02.2024 के अनुसार, राज्य की मतदाता सूचियों में लैंगिक अनुपात 920 की तुलना में 923 हो गया है। इसी प्रकार निर्वाचक जनसंख्या अनुपात भी 650 की तुलना में 654 हो गया है। कुल पंजीकृत मतदाताओं में 18-19 आयु वर्ग के मतदाताओं का प्रतिशत 2.94 है। राज्य में सभी मतदाताओं के लिए मतदाता पहचान पत्र (एपिक) जारी हो चुके हैं। राज्य में 199 विधानसभा क्षेत्रों की अंतिम प्रकाशित सूचियों के अनुसार, सर्विस वोटर्स की संख्या 1,41,821 है, इनमें 4,874 महिला है। साथ ही, प्रदेश भर में 36,090 स्थानों पर कुल मतदान केन्द्रों की संख्या 51,507 है।
