Each warrant, so allotted, is convertible into one fully paid-up equity share of the Company having face value of  $\gtrless$  10/- (Rupee Ten only) each in accordance with the provisions of SEBI ICDR Regulations, on payment of the balance consideration of  $\gtrless$  18.99/- per warrant ("Warrant Exercise Price"), aggregating to  $\gtrless$  37,99,50,000 (Rupees

Thirty-Seven Crore Ninety-Nine Lakhs Fifty Thousand) being Seventy-Five Percent of the aggregate consideration from the Allottee pursuant to exercise of conversion option against each such warrant, within Eighteen months from the date of allotment of the warrants.

We request you to take the above on record and the same be treated as compliance under the applicable provisions of the SEBI Listing Regulations.
