This is in continuation of our disclosures dated August 14, 2023, August 30, 2023 and September 26, 2023 under Regulation 30 read with Para B, Part A of Schedule III of SEBI (Listing Obligations and Disclosure Requirements), 2015 ("Listing Regulations").

Kindly note that pursuant to the dismissal of the review application on August 29, 2023, filed by the Company before the Allahabad High Court in *M/s. Jagran Prakashan Limited v. Shri Amar Kumar Singh and 4 Others* [CMRA No. 351/ 2023] (Item No. II in disclosure dated August 14, 2023), the Company has filed a Special Leave Petition ("SLP") before the Hon'ble Supreme Court of India being *M/s. Jagran Prakashan Limited v. Shri Amar Kumar Kumar Singh and Ors.* [S.L.P. (C) Diary No. 36823 of 2023], *inter alia*, challenging the final judgment dated August 29, 2023 in the said review application. The said SLP came up for hearing before the Hon'ble Supreme Court on October 19, 2023, whereby the Hon'ble Court was pleased to direct issuance of notice in the matter. The Company shall keep shareholders updated on the material developments in the said matter.

As informed earlier, we do not foresee any material impact of the matter on the business operations of the Company.
