Result of Postal Ballot

Sirs,

The Board of Directors of the Company at its meeting held on 10th January, 2018 has appointed me as scrutinizer to conduct the Postal Ballot as well as e-voting process in respect of two special resolutions set out in the notice dated 10th January, 2018 to the shareholders. I hereby submit my report. As desired the soft copy of the Postal Ballot Register is being sent by mail.

The Company had completed dispatch of 13,784 postal ballot forms through registered post on 07th & 8th February, 2018. Further on 07th February, 2018, 6005 postal ballot forms were also dispatched through speed post and 23,572 postal ballot forms through courier service along with business reply envelopes to its Members, whose names appeared on the Register of Members / list of beneficiaries as on 05th January, 2018. Similarly NSDL had also intimated on 08th February, 2018 the details of such voting process through e-mail to 41,350 beneficial owners whose e-mail id had been registered with the Company for the purpose of communication. However, as reported by NSDL on 6th March 2018 a total number of 1392 mails were bounced back. These shareholders were sent postal ballot forms through courier service on 07th March, 2018.

The Company had made arrangement of e-voting with NSDL. Only 179 shareholders had opted for e-voting. The result of such e-voting as intimated by NSDL is as under:

In the physical mode of voting, response was received from 515 shareholders. Particulars of all the postal ballot forms received have been entered in the Register forwarded herewith. The postal ballot forms were duly opened in my presence and scrutinized and the shareholding was matched / confirmed with the Register of Members of the Company / List of beneficiaries as on 05th January, 2018 Out of 515 forms received, 143 forms had to be rejected for reasons mentioned against each of them in the Postal Ballot Register.

All postal ballot forms received up to 5 P.M. on 12th March, 2018, the last date and time fixed by the Company for receipt of the forms were considered for my scrutiny. Thereafter, no envelope has been received till submission of this report. No mutilated or defaced ballot paper was received.
