Sub: Administrative Warning

1. This is with reference to your disclosure obligations under the SEBI (Listing Obligations and Disclosure Requirements), 2015 ("LODR").
2. You are found to have not provided timely updates on the material developments to your expansion project first disclosed vide disclosure dated June 25, 2021, and to have not provided any explanation on the reason for the delay in completion of the project in your disclosure dated April 01, 2022. This was in violation of Regulations 4(1)(d), 4(1)(e), 30(3) and 30(7) of the LODR Regulations read with Regulation 30(4)(i)(a) and Clause 1 of Para B of Part A of Schedule III of the LODR Regulations and SEBI circular CIR/CFD/CMD/4/2015 dated September 09, 2015.
3. The above violations have been viewed seriously. You are therefore warned to be careful in future and are advised to exercise due caution in future and avoid recurrence of such instances failing which appropriate enforcement action may be initiated in accordance with the provisions of SEBI Act, 1992 and the Rules and Regulations framed thereunder.
4. You are also advised to take corrective steps, place this communication and the corrective steps taken before the Board of Directors and disseminate a copy of this communication on the websites of the Exchanges that you are listed on.
