Man found hanging after getting thrashed by girlfriend's family in UP village

Unnao, Nov 15 (IANS) : A 22-year-old man was allegedly beaten up by the family members of the girl he loved in Uttar Pradesh's Unnao. The incident took place in Atiara Rasoolpur village of Unnao when he had come to meet the girl. The following day, on Wednesday, his body was found hanging from a noose in a mango tree, two hundred meters away from his girlfriend's village. The family members of the deceased have accused the girl's family of murder and hanging the body. In the post-mortem report, injury marks of beating with a stick were found on the right shoulder and hand.

Traffic advisory issued for India International Trade Fair in Delhi

New Delhi, Nov 15 (IANS) : In anticipation of the upcoming India International Trade Fair, set to take place at the Pragati Maidan here from November 14 to 27, Delhi Police have released a traffic advisory to apprise the public of the potential congestion on specific routes in the national capital. With daily attendance of approximately 40,000 visitors, the numbers are projected to surge to around one lakh visitors per day on weekends and holidays. As per the guidelines, commuters have been urged to take note of the advisory to navigate the city's roads effectively during the two-week-long event. The advisory, released on X, highlights specific areas prone to traffic congestion during the fair, including Mathura Road, Bhairon Marg, Ring Road, Sher Shah Road, and Purana Quila Road. Commuters not attending the trade fair are strongly urged to avoid these routes to ensure a smooth journey. The IITF, scheduled from November 14 to 27, will enforce a phased entry system. Business visitors will be allowed entry from November 14 to 18, followed by general public from November 19 to 27. The advisory specified designated entry gates for the visitors, exhibitors, mediapersons, and India Trade Promotion Organisation (ITPO) officials. The visitors with personal vehicles are directed to utilise the designated parking facilities, including basement parking No. 1 (entry and exit from Bhairon Marg), Bhairon Mandir parking on Bhairon Road, and Delhi Zoo parking.



Maurya clarifies remarks on Goddess Lakshmi

Lucknow, Nov 15 (IANS) : After creating a furore with his statements, Samajwadi Party (SP) leader Swami Prasad Maurya has clarified that his controversial comments on Goddess Lakshmi, saying they "are of a practical nature, based on truth, scientific and not hinged on someone's imagination". Maurya had questioned how Goddess Lakshmi could have four arms because no such person is born like this. In his clarification on Wednesday, the SP leader said: "I had not spoken about four arms alone, I also spoke about eight arms, 10 arms, 1,000 arms - no such child has ever been born in the country. If it did happen, I challenge them to tell me and I will accept it. "We can make somebody with 1,000 arms or 20 arms or 10 arms on the basis of our imagination. Imagination is just imagination. I said what is practical, based on truth, scientific and Sanatan too. I also spoke as per Sanatan Dharma and I said that people must respect their wives as she is the 'Grih Lakshmi' in the real sense." In a post on X on Monday, Maurya had said that every child born anywhere in the world has two hands, two legs, two ears, and two eyes and if a child with eight hands, and 10 hands has not been born till now, then how could Goddess Lakshmi be born with four hands. "While worshipping and honouring wife on the occasion of Deepotsav, I say that every child born in every religion, caste, race,



colour and country of the whole world has two hands, two legs, two ears, two eyes and a nose with two holes. There is only a head, stomach and back. If a child with four hands, eight hands, ten hands, twenty hands and a thousand hands has not been born till date, then how can Lakshmi be born with four hands?" In this regard, Congress leader Acharya Pramod Krishnam had criticised the SP leader for his remarks and demanded action against him. "He needs treatment. I will ask Yogi Adityanath to put a ban on Maurya speaking," Acharya Pramod said.



INS Sumedha makes port call to Namibia's Walvis Bay

New Delhi, Nov 15 (IANS) : INS Sumedha has made a port call at Walvis Bay in Namibia as part of navy's mission-based deployment to West Africa and Atlantic. The ministry said that INS Sumedha is equipped with several weapon systems, sensors, state-of-art-the-navigation and communication systems and electronic warfare system. It said that this port call is a manifestation of India's warm ties with Namibia, its commitment to enhance maritime security and demonstrate solidarity with friendly nations. The ministry said that India and Namibia have enjoyed warm and friendly bilateral relations sharing common values of democracy, development and secularism. "India, over the years, has extended training to a large number of Namibian military officers at various military institutions in India," the ministry in a statement said. The ministry said that the Indian Navy ships are regularly deployed as part of Indian Navy's mission of building 'Bridges of Friendship' and strengthening international cooperation with friendly countries as well as to address maritime concerns across the globe. "The current visit seeks to accentuate India's solidarity with friendly countries and, in particular, strengthen existing bonds of friendship with Namibia," the official added. The ministry said that the INS Sumedha is the third of the indigenously developed Naval Offshore Patrol Vessel (NOPV) of Saryu class deployed for multiple roles independently and in support of Fleet Operations.

CBI files charge sheet against then Dy Chief Engineer of NF Railway in DA case

New Delhi, Nov 15 (IANS) : The Central Bureau of Investigation (CBI) on Wednesday said that it has filed a charge sheet against Ranjit Das, then Deputy Chief Engineer (Survey/Construction) of the Northeast Frontier Railway in Guwahati in connection with a disproportionate assets case. A CBI spokesperson here said that the agency has filed a charge sheet.

Patna, Nov 15 (IANS) : Bihar BJP President Samrat Choudhary said on Wednesday that Chief Minister Nitish Kumar is now an elderly person who needs to take rest. "The way Nitish Kumar humiliated former Chief Minister and Dalit leader Jitan Ram Manjhi in the Assembly besides making sexist remarks in the House is highly condemnable and unfortunate. He is an elderly person now who needs rest," Choudhary said.



Ram Temple head priest condemns Swami Prasad Maurya's remark

Ayodhya, Nov 15 (IANS) : Acharya Satyendra Das, head priest of the Shri Ram Janmabhoomi temple, has said that Samajwadi Party (SP) leader Swami Prasad Maurya will be punished by the Gods over his remark on Goddess Lakshmi. Condemning Maurya's post questioning Goddess Lakshmi having four hands, the head priest said that the time has come for his punishment and he will soon realise that he was wrong. Satyendra Das said: "The time has come for his punishment and Gods and Goddesses will punish him soon. Realisation will dawn upon him that he was wrong. Sanatan Dharma people



should condemn him everywhere he goes." Explaining the reason for Goddess Lakshmi having four hands, the head priest said that the deity is "four-handed as she is from the dynasty of 'rakshas'". Satyendra Das said that Maurya is deaf and ignorant and there is no use of speaking to him. "He is deaf. Whatever you say, it does not have any effect on him. He will be punished... Since he is ignorant, nothing can be said about him."
