- 1. I, Binita Pandey, Practicing Company Secretary, ACS 41594, CP 19730, Partner of M/s. T. Chatterjee & Associates, FRN P2007WB067100, Company Secretaries Firm in Practice, have been appointed by Board of the Directors of DIC India Limited (hereinafter referred as the Company) on August 4, 2023 as the Scrutinizer for scrutinizing the voting by postal ballot through remote e voting, in a fair and transparent manner as per the provisions of Section 108 and 110 of the Companies Act, 2013 read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014 as amended by the Companies (Management and Administration) Rules, 2015 and Secretarial Standards, on the resolution contained in the Notice of Postal Ballot dated August 4,2023.
