Sub: A Request for granting Additional time to Publish FINANCIAL RESULTS for the year ended / 4<sup>th</sup> quarter ended 31<sup>st</sup> March 2018 in terms of Regulation 33(3) of SEBI (LODR) 2015.

With reference to the captioned subject we write to inform you that:

- (1) There was a major Fire incident in our manufacturing unit on 1<sup>st</sup> April 2018 which has already been communicated to your goodselves on 2<sup>nd</sup> April, 2018.
- (2) Due to this fire, the company suffered major damage to its plant including damage to key machinery, electrical installations, electrical fittings, furniture, fixture as well as the stock lying in the factory premises etc. Even the accounting records of the company have been damaged in the fire, due to the impact on computer systems.
- (3) As indicated in our letter dated 5th May, 2018, we are unable to conduct the audit of accounts due to this major mishap. We were anticipating to provide the unaudited financials, however, we have not been able to obtain sufficient data to generate the same in the absence of vital statutory records.
- (4) The management is taking all steps to obtain such data, information etc. from statutory authorities such as GST/Sales/VAT Department, Bankers, various parties for obtaining their duplicate invoice etc. on best available efforts basis. However, the process is time consuming and may take upto 6 months to complete entire process, including the Statutory Audit for the Year ended 31-Mar-2018.

We request you to allow us an additional period of 6 months to publish these statements. We shall endeavor to submit the same at the earliest.
