


Sub: Scrutinizers' Report on postal ballot by way of Remote e-voting/Voting by electronic means ("e-voting") conducted in terms of Section 108 and 110 of the Companies Act, 2013 read with Rule 20 and Rule 22 of the Companies (Management and Administration) Rules, 2014, as amended from time to time in respect of passing of the resolutions contained in the Postal Ballot Notice dated March 26, 2024.

Dear Sir.

I, Mayank Dubey, Proprietor of M. D. & Associates, Practicing Company Secretaries, having office at B-09, H-140, BSI Business Park, Sector- 63 Noida, Uttar Pradesh - 201301, have been appointed as Scrutinizer by the Board of Directors of Insecticides (India) Limited ("The Company") for scrutinizing the postal ballot by way of voting through electronic means / e-voting, in respect of passing of the resolutions contained in the Postal Ballot Notice dated March 26, 2024 ("Notice") in a fair and transparent manner.

MANAGEMENT RESPONSIBILITIES

The Management of the Company is responsible to ensure the compliance with the requirements of the relevant provisions of: (i) the Companies Act, 2013 and the rules made thereunder including circular no. 14/2020, 17/2020, 20/2020, 22/2020, 33/2020, 39/2020, 10/2021, 20/2021, 03/2022 and 10/2022, 09/2023, dated April 8, 2020, April 13, 2020, May 05, 2020, June 15, 2020, September 28, 2020, December 31, 2020, June 23, 2021, December 08, 2021, May 05, 2022, December 28, 2022 and September 25, 2023 respectively issued by the Ministry of Corporate Affairs ("MCA Circulars"); (ii) the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), the BSE Limited and National Stock Exchange of India Limited ("Stock Exchanges"); and (iii) Secretarial Standard on General Meetings ("SS-2") issued by the Institute of Company Secretaries of India and any other applicable laws, rules and regulations, related to postal ballot by means of e-voting.



SCRUTNIIZER'S RESPONSIBILITY


My responsibility as scrutinizer is restricted to prepare a scrutinizers' report of the votes cast in favor and against by the members for the resolutions stated in the Notice; based on the reports generated from secured e-voting system provided by Central Depository Services (India) Limited ("CDSL") i.e. www.evotingindia.com, an authorized agency engaged by the Company to provide e-voting facilities till the time fixed for closing of the voting process i.e. Sunday, April 28, 2024, 5:00 P.M. (IST).

CUT-OFF DATE

The Members of the Company as on the "cut-off date" i.e. Friday, March 22, 2024 were entitled to vote on the proposed resolutions to be passed through postal ballot by way of e-voting means as set-out in the Notice of Postal Ballot and their shareholding as on cut-off date has been reckoned for the purpose of arriving at the results of the postal ballot.

REMOTE E-VOTING PROCESS

- 1. The e-voting period remained open from Saturday, March 30, 2024 at 9:00 A.M. (IST) till the close of working hours i.e., 5:00 P.M. (IST) on Sunday, April 28, 2024, and the e-voting module was blocked by CDSL thereafter.
- 2. On Thursday, March 28, 2024, the Company had completed the dispatch of Postal Ballot notice to those Members whose name(s) appeared in the Register of Members/ List of beneficial owners as on the cut-off date i.e., March 22, 2024 received from Depositories i.e. National Securities Depository Limited ("NSDL"), Central Depository Services (India) Limited ("CDSL"), Registrars and Share Transfer Agent of the Company ("RTA") and whose e-mail id's were registered with the Depositories or with RTA. Pursuant to the MCA Circulars, the Company had dispatched the notice through e-mails only. Thus, the Company was not required to dispatch the postal ballot notice to those members whose e-mail ID's were not registered with the Company and/or Depositories.
- 3. As per rule 20 read with rule 22 of the Companies (Management and Administration) Rules, 2014, as amended and Regulation 47 of listing regulations, Newspaper Advertisements with respect to Postal Ballot Notice were published by the Company in "Business Standards" (English), all editions and in "Business Standards" (Hindi), New Delhi edition, on March 29, 2024 informing about the completion of dispatch of Postal Ballot notice to those Members who registered their e-mail id's with the depositories or with RTA of the Company along with other related matters mentioned therein. However, the Company had also given an option to the members to register their e-mail Id's with the Company and/or their depository participants, in case not yet registered.
- 4. I had monitored the process of e-voting through the scrutinizer's secured link provided by CDSL through its designated website.



 After completion of e-voting, votes cast by the Members were unblocked in the presence of two witnesses, Mr. Nitin Yadav and Ms. Divya Gupta who are not in the employment of the Company.


