

**Subject:** Scrutinizer's Report on the Postal Ballot Exercise conducted through electronic means ('Remote e-voting'), from Thursday, March 21, 2024 at 9.00 a.m. (IST) to Friday, April 19, 2024 at 5:00 p.m. (IST), in compliance with provisions of Sections 108 and 110 of the Companies Act, 2013 read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014.

Dear Sir,

- I, Dinesh Joshi, Practicing Company Secretary and Designated Partner of KANJ & Co. LLP, Pune, was appointed by Deepak Nitrite Limited ("the Company") as the Scrutinizer to conduct the Postal Ballot Exercise through Remote e-voting process, in a fair and transparent manner, carried out in compliance with Sections 108 and 110 of the Companies Act, 2013 ("the Act") and Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014 ("the Rules") read with the General Circular No. 14/2020 dated April 8, 2020 and the General Circular No.17/2020 dated April 13, 2020; 22/2020 dated June 15, 2020; 33/2020 dated September 28, 2020 and 39/2020 dated December 31, 2020, 10/2021 dated June 23, 2021, 20/2021 dated December 8, 2021, 03/2022 dated May 5, 2022, 11/2022 dated December 28, 2022, 09/2023 dated September 25, 2023("MCA Circulars") and in compliance with Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI (LODR) Regulations, 2015"), in connection with the passing of the resolutions as mentioned in the Notice of Postal Ballot dated 20<sup>th</sup> March, 2024, hereby submit my report as under:
- In terms of the MCA Circulars, the Company had sent the Postal Ballot Notice in electronic form only to those Shareholders whose email ids were registered with the Company or Link intime India Private Limited, Registrar and Share Transfer Agent ('RTA') of the Company or Depositories / Depository Participants.
- 2. The required instructions for Remote e-voting by the shareholders were duly mentioned in the Postal Ballot Notice sent to the shareholders of the Company.
- 3. The shareholders holding the shares as on the 'cut-off' date i.e., Friday, March 15, 2024, were entitled to vote on the proposed resolution through Remote e-voting.
- 4. The Management of the Company is responsible for ensuring compliance with the requirements of the Act and the Rules there under and SEBI (LODR) Regulations, 2015, relating to the items being placed for approval of the shareholders through Postal Ballot.
- 5. My responsibility as the Scrutinizer of the voting process (through Remote e-voting), was restricted to scrutinize the Remote e-voting process, in a fair and transparent manner and to prepare a Scrutinizer's Report of the votes cast in favour and against the resolutions stated in the Postal Ballot Notice, based on votes cast through Remote e-voting as also the reports generated from the e-voting



system from <a href="https://www.evoting.nsdl.com">https://www.evoting.nsdl.com</a> the authorised agency to provide the Remote e-voting / e-voting for the Postal Ballot facilities and engaged by the Company for that purpose along with the assistance of RTA.

- 6. The Remote e-voting process was conducted from Thursday, March 21, 2024 at 9.00 a.m. (IST) upto Friday, April 19, 2024 at 5:00 p.m. (IST).
- 7. The Notice of Postal Ballot and e-voting, as required under Rule 22 Sub-Rule 3 of the Rules and Regulation 47 of the SEBI (LODR) Regulations, 2015, was published in English language in Indian Express, an English language Newspaper as well as in Gujarati language in Financial Express, Gujarati language Newspaper, on Thursday, March 21, 2024.
- 8. I unblocked the Remote e-voting on Friday, April 19, 2024 at 5:15 p.m. (IST) and counted the votes cast, in the presence of two witnesses, who are not in the employment of the Company.
- 9. The votes cast by Remote e-voting were subsequently counted by me and reconciled with the records maintained by the RTA of the Company and the authorizations lodged with the Company.
