In furtherance to our earlier letters dated 8th April, 2024 and 12th April, 2024, with respect to the Issue which opened on Monday, 8th April, 2024 and closed on Friday, 12th April, 2024, we wish to inform that the securities issue committee of the board of directors of the Company ("Committee") has, at its meeting held today, i.e., 13th April 2024, approved the allotment of 1,09,89,010 Equity Shares of face value ₹1 each to eligible qualified institutional buyers at the issue price of ₹455 per Equity Share, *i.e.*, at a premium of ₹454 per Equity Share (which includes a discount of ₹22.33 per Equity Share (4.68% of the floor price) to the floor price of ₹477.33 per Equity Share, aggregating to ₹4,99,99,99,550 (Rupees Four Hundred and Ninety Nine Crores Ninety Nine Lakhs Ninety Nine Thousand Five Hundred Fifty only), pursuant to the Issue.

The Issue opened on 8th April 2024 and closed on 12th April, 2024 and the same was intimated to you through our letters dated 8th April 2024 and 12th April, 2024, respectively.

Further, we have enclosed herewith the list of allottees who have been allotted more than five percent (5%) of the Equity Shares offered in the Issue, marked as **Annexure A**

Pursuant to the allotment of Equity Shares in the Issue, the paid-up equity share capital of the Company stands increased from ₹8,68,01,898 comprising of 8,68,01,898 Equity Shares of face value of ₹1 each to ₹9,77,90,908, comprising of 9,77,90,908 Equity Shares of face value of ₹1 each. The shareholding pattern of the Company before and after the Issue will be submitted along with listing application in the format specified in Regulation 31 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("SEBI Listing Regulations").

The meeting of the Committee commenced at 10.15am and concluded at 10.35am .

We request you to take the above on record and the same be treated as compliance under the applicable provisions of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended.
