so boosting sales. Manufacturers sell discounted EVs and then seek the subsidised amount from the centre. This amount is disbursed with the lag of a quarter after localisation claims are verified by MHI.

In her speech, Sitharaman said the government will expand and strengthen the e-vehicle ecosystem by supporting manufacturing and charging infrastructure. "Greater adoption of e-buses for public transport networks will be encouraged through payment security mechanism," she added.

Launched in 2019, FAME II has successfully subsidised sale of nearly 12 lakh two-wheelers, 1.41 lakh three-wheelers, and 16,991 four-wheelers till date. The allocation for FAME II was ₹10,000 crore of which ₹5,829 crore has been disbursed under the scheme which was initially laun-

ched for three years but extended to five, ending in 2024.

But implementation of the FAME programme has been marred with issues as manufacturers falsified localisation claims and availed subsidies for mispriced vehicles. The lacunae were addressed with stricter compliance that now delays disbursement to manufacturers.

Raising another red flag, the Parliamentary Committee on Estimates questioned the high cost of EV chargers supported under the FAME II scheme. The Committee said it was concerned since charging stations sanctioned under FAME I costed a third of those under FAME II. In its response MHI cited higher capacity and localisation as a reason for the escalated cost under FAME II.

There are two parts to the implementation of the scheme. In one, the SPVs will reach out to consumers having up to 3kW of load and the 40% non-subsidized portion of the capital cost would be loaned by the SPV.

"It is incumbent upon the SPV to get in touch with such consumers," Singh said.

The excess power units that will be generated through the rooftop solar project on such households, monitored through virtual net metering, will go towards paying off the loan by the SPV.

"We calculate that the loan will be paid off in 10 years," Singh said.

After the loan is paid off, the benefits of selling the excess electricity to the grid or distribution companies will also go to the household as the SPVs will exit the project.

Russian Crude Oil Share in Imports Dips to 25% in Jan

At 1.2 mbpd, India purchases 9% less Russian oil in Jan


New Delhi: The share of Russian oil in India's crude imports fell to 25% in January from 31% in December 2023 and an all-time high of 44% in May last year as price discounts narrowed, the Red Sea attacks drove up freight and US sanctions hurt shippers.

India imported 1.2 million barrels per day (mbd) of Russian crude in January, 9% less than in December, according to energy cargo tracker Vortexa. India's import volumes were the same as China's seaborne import of Russian oil. Indian state refiners imported 21% less Russian crude in January while private sector refiners took 10% more.

"The narrowing of Russian crude discounts versus Middle Eastern crude, recent US sanctions on shipowners carrying Russian crude above the price cap and rising tanker premiums as a result of the Red Sea attacks have made Russian crude less attractive for Indian refiners in recent months," said Serena Huang, an analyst at Vortexa.

Attacks in the Red Sea by Yemen-based Houthi Rebels haven't had much effect on Russian barrels on that route. Freight and insurance rates, however, have gone up in general and many ships are taking the longer alternative route to avoid trouble.

All key Russian crude grades are trading above the \$60 per barrel cap, making it harder for Indian refiners to receive cargoes or pay for them. Urals, the flagship Russian crude which has been the mainstay of Indian imports, is trading near \$70 per barrel while international benchmark Brent is around \$80.
