

2) The Company has only single reportable business segment and hence no disclosures have been made in this regard.


3) The Company has incurred a net loss after tax of Rs. 17.25 Lakhs (Quarter ended 30 September 2022 Rs. 16.41 Lakhs) during the Quarter ended 30 September 2023 and as on that date, has accumulated losses of Rs. 524.21 Lakhs (as at 30 June 2023 Rs. 506.97 Lakhs). Although Company has currently adverse financial ratios and no cash inflows from operating activities, considering the performance and networth of the investee company, i.e., Innovassynth Technologies (India) Limited and Further on occurrence of any of the two mentioned events in future with respect to its investee company, Innovassynth Technologies (India) Limited ('ITIL') i.e. declaration of dividend by ITIL, or selling off partial/complete investment stake in ITIL, the Company will be able to generate additional cash flows and hence the financial results/ financial statements have been prepared considering the Company on going concern assumption.

4) The Code on Social Security 2020 ('the Code') relating to employee benefits, during the employment and post-employment, has received Presidential assent on 28 September 2020. The Code has been published in the Gazette of India. Further, the Ministry of Labour and Employment has released draft rules for the Code on 11 November 2020. However, the effective date from which the changes are applicable is yet to be notified and rules for quantifying the financial impact are also not yet issued. The Company will assess the impact of the Code and will give appropriate impact in the financial statements in the period in which, the Code becomes effective and the related rules to determine the financial impact are published.

5) The figures for the current quarter ended 30th September 2023 and quarter ended 30th September 2022 are the balancing figures between the published year to date figures in respect of the period ended 30th September 2023 and 30th September 2022, respectively and published figures upto the quarter ended 30th June, 2023 and 30th June 2022, respectively which were subjected to limited review.
