

Although Company has currently adverse financial ratios and no cash inflows from operating activities, considering the performance and networth of the investee company, i.e., Innovassynth Technologies (India) Limited and Further on occurrence of any of the two mentioned events in future with respect to its investee company, Innovassynth Technologies (India) Limited ('ITIL') i.e. declaration of dividend by ITIL, or selling off partial/complete investment stake in ITIL, the Company will be able to generate additional cash flows and hence the financial results/ financial statements have been prepared considering the Company on going concern assumption.
