Dear Sir/Madam,

Pursuant to Regulation 30 read with Part A of Schedule III, of the Listing Regulations, this is to inform that the Board of Directors of the Company, at its Meeting held on December 04, 2023 has, inter-alia, considered and approved;

- (a) the proposal for fund raising up to to an amount of Rs. 4,20,00,000 (Rupees Four Crores Twenty lacs Only) by way of:
 - issuance of upto 10,00,000 (Ten lacs) Equity Shares of the Company having face value of Rs. 10/- (Rupees Ten) each at a price of Rs. 14/- per share (including premium of Rs. 04/- per share) aggregating upto Rs. 1,40,00,000 (Rupees One Crores Forty lacs Only) to the Investors falling under the Non Promoter category on preferential basis through private placement subject to the approval of Members of the Company.
 - ii. issuance of upto 20,00,000 (Twenty lacs) convertible Warrants at a price of Rs. 14/- per Warrant with a right to the Warrant holders to apply for and be allotted 1 (One) Equity Share of the face value of Rs. 10/- (Rupees Ten) each of the Company at a premium of Rs. 04/- per share aggregating upto Rs. 2,80,00,000 (Rupees Two Crores Eighty lacs Only) to the entities falling under Promoter and Non Promoter Category on preferential basis through private placement subject to approval of the Members of the Company.
- (b) the proposal to increase the authorized capital of the Company to Rs. 7,50,00,000 (Rupees Seven crores fifty lacs only), subject to approval of the Members of the Company

Kindly take note that an Extra-Ordinary General Meeting is scheduled to be held on Thursday, January 04, 2024 for the purpose of seeking approval of the Members. The Notice of the same shall be sent in due course.
