In continuation to our letter with ref no. SEAMEC/BSE/SMO/147/19 dated May 06, 2019, we wish to inform you that the Board of Directors of the Company at its meeting held today has interalia:

- (i) Approved the Audited Financial Statements (Standalone and Consolidated) for the year ended March 31, 2019 and the Audited Financial Results (Standalone and Consolidated) for the quarter / year ended March 31, 2019, as recommended by the Audit Committee.

- (iv) Considered and Approved that pursuant to Regulation 16 of the SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015 and audited financial statements of the Company for the year ended March 31, 2019; Seamec International FZE, a wholly owned subsidiary of the Company, shall be considered as a material subsidiary of the Company as per the criteria defined under the foregoing Regulations.
