

CRICKET FEVER BEFORE GRAND FINALE



For cricket enthusiasts, Vadodara a pit stop before final

VADODARA, NOVEMBER 18

YATIN PATIL and his five friends drove down to Vadodara from Mumbai Saturday to make a night halt as hotels in Ahmedabad are "fully booked" a day ahead of the much awaited Cricket World Cup final between India and Australia

Patil and his friends are among many cricket enthusiasts travelling to Gujarat from other cities to witness the clash of the titans Sunday.

"We are a group of six and were lucky to get tickets for the match. When we inquired about hotel rooms in Ahmedabad, the affordable hotels were sold out. So we decided to stop over at Vadodara for the night and drive to the venue early in the morning as it is not a big distance... We were able to find inexpensive hotel rooms and may also explore the city for a bit before leaving for the match," Patil said.

Similarly, software executive Ishani Shetty and her friends travelled to Vadodara from Pune and will head to Ahmedabad by another train early Sunday morning. The distance between Pune and Ahmedabad is not too much and so when we managed to get tickets almost at the last minute for the match and then also for the train, we decided we would stop over for the night at Vadodara and then head to Ahmedabad. Hotel rooms in Vadodara were priced as usual and so it is also not heavy on our pockets. We have booked ourselves on an early morning train to be in time for the security checks and other processes at the stadium as we are expecting a long queue too," said Shetty.

Jatin Shah, part of a group of banking executives from Mumbai who has decided to make a pit stop at Vadodara before heading to Ahmedabad by cab Sunday morning, said, "We were expecting a huge rush in Ahmedabad because of the VIP movement. We had decided early on that we would stay at Vadodara. We arrived in Vadodara Friday and also clubbed the visit to Statue of Unity. We will reach Ahmedabad by Sunday 10 am to be in time at the venue and not miss a thing".

Hotels in Vadodara are mostly booked but the managements say the rush is "normal witnessed during Diwali week". An executive at a four-star hotel in the city said, "We are almost sold out for this weekend and we are expecting more last-minute bookings due to the cricket match. The rooms are dynamically priced but are affordable. It is difficult to classify if the crowd is for the match or for the ongoing Diwali vacations as many guests are extending their stay beyond the match days, too."

Another executive of a fivestar hotel said it has seen "more than usual" bookings for the weekend. "Guests have checkedin in big numbers this weekend. However, we are not aware of their final destinations. We have many one-night bookings for Saturday and also a couple of guests, who have requested transport assistance to Ahmedabad on Sunday for the match," the management of the hotel based in Alkapuri said.

Over 6K personnel on guard today: Police

PRESSTRUST OF INDIA AHMEDABAD, NOVEMBER 18

MORETHAN 6,000 security personnel will be deployed in Ahmedabad city and the Narendra Modi stadium during the World Cup final between mighty India and five-time champions Australia on November 19, a senior police official said Saturday.

Prime Minister Narendra Modi and Australian Deputy PM Richard Marles will be among the key personalities who are expected to attend the ICC Cricket World Cup grand finale in the Motera area of the city, said Ahmedabad Commissioner of Police GS Malik

Addressing a press conference, Malik said elaborate security arrangements, with personnel from Gujarat police, Rapid Action Force (RAF), home guards and others, have been made keeping in mind the movement of over one lakh spectators and the presence of several dignitaries at the stadium.

"Over 6,000 police personnel will be deployed to ensure that the mega event passes off without any trouble. Of these 6,000

stationed inside the stadium, while others will be deployed to guard other key locations, such as hotels where players and other dignitaries are staying," said Malik.

While one company of RAF will be deployed inside the stadium, another will be on duty outside the stadium, said Malik, adding that city police have created a temporary command and control centre inside the venue equipped with a wireless network that works even when mobile communication fails.

Malik said four senior IPS officials of IG and DIG rank along with 23 deputy commissioner of police (DCP) rank officials will supervise and guide the personnel on the match day. They will be assisted by 39 assistant commissioners of police and 92 police inspectors, said Malik.

To respond to any chemical, biological, radiological and nuclear (CBRN) emergencies during the match, teams from the National Disaster Response Force (NDRF) will also be deployed in the city, said the Ahmedabad police chief.

He added that 10 teams of Bomb Detection and Disposal

Chetak Commandos, an elite unit, will be stationed near the stadium.

Asked if the police have received any inputs regarding a possible threat, Malik said the media should not highlight such threats issued by unknown per-

"We are well prepared for any threat. Some people sitting in Canada or any other country just send a threat email or share audio or video of a threat and the media hypes it. I believe that there is no need to give recognition to such things," said

Other dignitaries who are expected to attend the final match at the stadium include Union Home Minister Amit Shah, US Ambassador to India Eric Garcetti, Minister for Home Affairs and Law of Singapore K. Shanmugam, Tamil Nadu minister Udhavanidhi Stalin, Assam Chief Minister Himanta Biswa Sarma, Meghalaya CM Conrad

Narmada rehabilitation colonies to be assimilated with nearest villages: Govt

ABOUT 80-ODD rehabilitation colonies constructed to house the displaced families of the Sardar Sarovar Dam project will now be assimilated with the villages located nearest to the respective colonies, stated an official release from the Gujarat government, Saturday.

The colonies in six districts, including Vadodara (38), Chotta Udepur (14), Narmada (13), Bharuch (9), Panchmahal (5) and Kheda (1), will be part of this process. The assimilation with the nearest villages will help the

residents get access to the services being provided by the local gram panchayats.

The residents of the colonies can also take part in the decisionmaking process of the village, the release added. Former government officials who have dealt with the rehabilitation of the families displaced by the Narmada dam said there were over 200 such colonies across the state.

"It was a long awaited decision. The colonies needed to have some sort of exit policy as they were being managed by the Sardar Sarovar Punarvasat Agency (SSPA) of the state government," a former state government official said.

30 children suffer burns as helium balloons burst due to firecrackers

Ahmedabad: Around 30 children, aged between 15 and 16 years, Saturday received burn injuries after a cluster of helium balloons exposed to firecrackers burst during a religious ceremony at a newly inaugurated Ganesh temple in Mehsana.

Achal Tyagi, Superintendent of Police (Mehsana), told The Indian Express that the explosion took place at a temple in Unjha.

"Around 12.45 pm, during
