Report of Scrutinizer for Voting on Postal Ballot through Remote e-Voting

To,

The Chairman, GIC Housing Finance Limited 6th Floor, National Insurance Building 14, Jamshedji Tata Road, Churchgate, Mumbai – 400020

Subject: Scrutinizer's Report on Voting through remote e-Voting for Postal Ballot conducted in terms of Sections 108 and 110 of the Companies Act, 2013 (the "Act") read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014.

- A. In accordance with Sections 108 and 110 of the Act, read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014, I, Omkar Dindorkar (Certificate of Practice No. 24580), Designated Partner of M/s. MMJB & Associates LLP, Practicing Company Secretaries, have been appointed as Scrutinizer by the Board of Directors of the Company at their meeting held on Friday, November 03, 2023, for votes cast through electronic means for the postal ballot process in respect of the resolution as set out in the Postal Ballot Notice dated November 03, 2023 ("Notice").
- B. Members approval was sought for special businesses i.e.,
 - 1. Appointment of Smt. Rajeshwari Singh Muni (DIN 09794972) as a Non-Executive Director and
 - 2. Appointment of Shri Ramaswamy Narayanan (DIN 10337640) as a Non-Executive Director & Chairman.
- C. Pursuant to Sections 108 and 110 of the Act and Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014, General Circular No. 14/2020 dated April 08, 2020, 17/2020 dated April 13, 2020 and 09/2023 dated September 25, 2023 issued by the Ministry of Corporate Affairs ("MCA") (hereinafter collectively referred to as "MCA Circulars") [including any statutory modification(s) or re-enactment(s) thereof for the time being in force], Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") and also Circulars dated May 12, 2020, January 15, 2021, May 13, 2022, October 07, 2023 issued by the Securities and Exchange Board of India (collectively referred to as "SEBI Circulars"), the Secretarial Standard 2 on General Meetings issued by the Institute of Company Secretaries of India, and other applicable laws and regulations (including any statutory modification(s) and/or re-enactment(s) thereof for the time being in force), the items of special business as set out in the Notice were placed for approval of the members of the Company through remote e-Voting only. The Company has confirmed that the

electronic copy of the Notice and Explanatory Statement along with the process of remote e-Voting in terms of the MCA Circulars were sent to those Members on Wednesday, November 15, 2023, whose e-mail addresses were registered with the Company/Depositories and whose names appeared in the Register of Members of the Company or Register of Beneficial Owners maintained by the Depositories as on Friday, November 10, 2023 ("cut-off date").

- D. The Company had appointed M/s. KFin Technologies Ltd. (Kfintech) for providing remote e-Voting facility to the Members of the Company.
- E. Members were required to communicate their assent or dissent only through remote e-Voting system in terms of the MCA Circulars.
- F. The remote e-Voting period commenced on Thursday, November 16, 2023 from 9.00 a.m. (IST) and ended on Friday, December 15, 2023 at 5.00 p.m. (IST).
- G. Accordingly, the votes cast through remote e-Voting were taken into account and at the end of the remote e-Voting period, on Friday, December 15, 2023 at 5.00 p.m. (IST), the remote e-Voting module was thereafter disabled for voting by Kfintech. The remote e-Voting summary statement was thereafter downloaded from e-Voting website of Kfintech i.e. https://evoting.kfintech.com.
- H. The register, in accordance with Rules 20(4)(xiv) and 22(10) of the Companies (Management and Administration) Rules, 2014, has been maintained electronically to record the assent or dissent received, mentioning the particulars of name, address, folio number or client ID of the Members, number of shares held by them and nominal value of such shares. There were no shares with differential voting rights in the Company, hence, there is no requirement of maintaining the list of shares with differential voting rights.
