Sub: Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Reguirements) Regulations, 2015

Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated 13th July 2023, we inform you that the Collector and Additional Superintendent of Stamps, Gujarat State, Gandhinagar, vide its Order dt. 20th January 2024, received by us on 31st January 2024, under the Gujarat Stamp Act, 1958, has raised a demand for deficit stamp duty of Rs. 100.80 lac on registration of a Mortgage Deed with the office of Sub-Registrar, Songadh, Gujarat, in connection with the borrowings availed by the Company and imposed a penalty of Rs. 100.80 lac. The Company would file appeal before the Appellate authorities against the aforesaid Order. There is no material impact on financial, operation or other activities of the Company due to the said Order.
