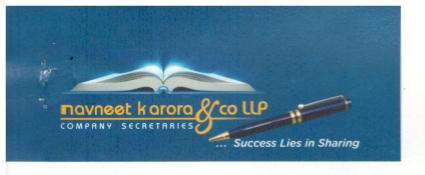

I have completed the scrutiny of remote e-voting of postal ballot (e-voting) and submit my report as under:

- 1. The Company has on 3<sup>rd</sup> January 2024, completed the dispatch of Notice to its members via email through CDSL along with the details of Login ID and password to its members whose email ID was registered with the Company or its RTA as on cut-off date i.e. 28<sup>th</sup> December, 2023. Total shareholders of the Company as on the cut-off date was 12,521.
- 2. The shareholders of the Company had option to vote is restricted only through remote e-voting facility i.e. by casting votes electronically instead of submitting postal ballot forms. Shareholders cast their votes on the designated website <a href="https://www.evotingindia.com">www.evotingindia.com</a> of CDSL.
- 3. The details of e-voting as recorded through online platform provided by CDSL have been entered in a computerized register separately maintained for the purpose.
- 4. All casting of votes electronically through CDSL portal up to the close of working hours i.e. 05.00 p.m. on 03<sup>rd</sup> February 2024, the last date and time fixed by the company for receipt of the forms were considered for my scrutiny.
- 5. In view of relaxation given by Ministry of Corporate Affairs and Securities and Exchange Board of India, the Company has not dispatched physical ballots. Further, the Company has also not received any physical ballot form and accordingly, voting done through e-voting means only was considered for this report.
- 6. As per rule 20 read with rule 22 of the Companies (Management and Administration) Rules, 2014, as amended and Regulation 47 of listing regulations, Newspaper Advertisements with respect to Postal Ballot Notice were published by the Company in "Financial Express" (English), all editions and in "Jansatta" (Hindi), Delhi edition on January 04, 2024 informing about the completion of dispatch of Postal Ballot notice to those Members who registered their e-mail id's with the depositories or with RTA of the Company along with other related matters mentioned therein
