Sub.: Intimation of Temporary disruption of Operations at Andhra Plant due to cyclone.

Pursuant to Para B of Part A under Schedule III of regulation 30 of the SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015, we would like to inform that operations at MDF Plant situated at 97/1, 98/1 & 99/1, Rauthu Suramala (V), Thottambedu (M), District – Chittor, Andhra Pradesh, PIN-517642 have been disrupted since yesterday due to Cyclone Michaung which intensified into a very severe cyclonic storm.

The Company is taking adequate steps to ensure resumption of operations of the plant at the earliest. During the aforesaid period, the Company will continue to service the customers uninterruptedly from the inventory of finished goods subject to logistics availability. We shall update you upon resumption of operations at the above plant.

1	Expected quantum of loss / damage cause	The Company is in the process of ascertaining the loss/damage caused by Cyclone Michaung.
