Further the Finance Act, 2021 has brought in section 206AB effective from July 1, 2021 wherein tax would be deducted at higher rates (twice the specified rate) on paymen of dividends to a specified person who has not furnished the return of income for the assessment year relevant to the previous year immediately preceding the financial year in which tax is required to be deducted, for which the time limit for furnishing the return of income under sub-section (1) of section 139 has expired and the aggregate of tax deducted at source and tax collected at source in his case is rupees fifty thousand or more in the said previous year: The Company is accordingly required to deduct TDS twice the rate specified under the Act in respect of payment of dividend to such specified persons.

The TDS rate would vary depending on the residential status of the Shareholder and the documents submitted by them and accepted by the Company in accordance with the applicable provisions of the Act.
