SCRUTINIZER'S REPORT

[Pursuant to Section 108 & 110 of the Companies Act, 2013 and Rule 20 & 22 of the Companies (Management and Administration) Rules, 2014 read with amendments made thereto and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as amended]

To, Mr. Bhaskar Bhat Chairman Rallis India Limited

Dear Sir,

- 1. I, Bhaskar Upadhyay, Practicing Company Secretary (Membership No. FCS 8663 / C.P No. 9625), Partner, M/s N.L. Bhatia & Associates, (UIN: P1996MH055800), have been appointed as a Scrutinizer by the Board of Directors of Rallis India Limited ("the Company") for the purpose of scrutinizing the remote e-Voting on Resolutions, carried out through Postal Ballot and ascertaining the requisite majority on e-Voting undertaken as per the provisions of Section 108, 110 & other applicable provisions, if any of the Companies Act, 2013 ("the Act") read with Rule 20 & 22 of the Companies (Management and Administration) Rules, 2014 ("the Rules"), 2014 read with amendments made thereto and Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations") as amended, on the businesses contained in the Notice of Postal Ballot sent to the Equity Shareholders of the Company.
- The Management of the Company is responsible to ensure the compliance with the
 requirements of the Act, Rules, Circulars and Notifications issued by the Ministry of
 Corporate Affairs ("the MCA Circulars") and SEBI Listing Regulations relating to voting
 through electronic means on the resolutions contained in the Postal Ballot Notice dated
 February 29, 2024.
- 3. The Postal Ballot Notice dated February 29, 2024 along with statement setting out material facts under Section 102 of the Act in respect of the resolutions mentioned in

the Postal Ballot Notice, as confirmed by the Company, was sent, electronically only to the Members whose names appeared in the Register of Members / List of Beneficial Owners as received from Link Intime India Private Limited, the Company's Registrar and Transfer Agent ('RTA') / Depositories and whose email addresses were registered with the Company / RTA / Depository Participants.

- 4. My responsibility as a Scrutinizer for the e-Voting during the Postal Ballot is restricted to make Scrutinizer's Report of the votes cast "in favour" or "against" the Resolutions, stated in the Notice dated February 29, 2024, based on the reports generated from the e-Voting system provided by National Securities Depository Limited ('NSDL'), the authorized agency to provide remote e-Voting facilities, engaged by the Company.
- 5. Further to above, I submit my Report as under:
 - 3.1. The Company has provided the remote e-Voting facility through NSDL. The Company had uploaded all the items of businesses to be transacted on the Website of the Company and also on the website of its service provider to facilitate its Members to cast their votes through e-Voting;
 - 3.2. The Notice of the Postal Ballot dated Thursday, February 29, 2024, contained the detailed procedure to be followed by the Members who were entitled to cast their votes electronically as provided under Rule 20 of the Companies (Management and Administration) Rules, 2014 read with amendments made thereto and notifications issued by the Ministry of Corporate Affairs ('MCA').
 - 3.3. As prescribed in the said Rules and MCA Circulars, the Company has also published an advertisement in newspapers on Wednesday, March 20, 2024 in Business Standard, Free Press Journal (English) and in Navshakti (Marathi) and it carried the required information as specified in the said Rules;
 - 3.4. The Members of the Company as on the "Cut-off' date" i.e. on Friday, March 15, 2024 were entitled to vote on the Resolutions, as set out in the Notice of the Postal Ballot;
 - 3.5. The remote e-Voting commenced on Wednesday, March 20, 2024 (9:00 A.M. IST) and ended on Thursday, April 18, 2024 (5:00 P.M. IST). Thereafter, the e-Voting was disabled;
