Actor Prince Narula offers prayers at Mahakaleshwar temple

UJJAIN, Feb 11 (ANI)

ACTOR Prince Narula on Saturday offered prayers at Mahakaleshwar temple located in Ujjain district. He also participated in the Bhasma Aarti performed here on the occasion and took blessings of Baba Mahakal (Lord Shiva). 'Bhasma aarti' (offering with ashes) is a famous ritual here. According to the priest of the temple, following the tradition the doors of Baba Mahakal were opened in the Brahma Muhurta and after that a holy bath of Lord Mahakal was performed with Pancharit, which included milk, curd, ghee, sugar and honey. Later the Bhasma Aarti was performed along with beating drums and blowing conch shells. Actor Narula told ANI, "I am very happy to visit here. I felt a different energy here today. I prayed to Baba Mahakal to keep me and my family healthy."

Associate Professor's post aspirant's petition dismissed

JUSTICE Vivek Agarwal has dismissed the petition filed by Dr Yadendra Prasad Dubey, Assistant Professor. Justice Vivek Agarwal has said in the order that this finding get support from another aspect that the difference between the score secured by the private respondent Dr Vishnu Narayan Mishra Associate Professor and petitioner is so huge that minor or marginal errors even if taken into consideration are not sufficient to give an edge to the petitioner's case. Therefore, on both the touchstone of there being no violation of the UGC guidelines and further there being no material to show that the experts were acting in a mala fide or partial manner, this court cannot definitely sit as an appellate authority over the judgments of the experts. Accordingly, this petition is hereby dismissed." The petitioner filed this petition against the Principal Secretary Higher Education, Bhopal, Vice Chancellor Of Indira Gandhi National Tribal University (IGNTU), Amarkantak, Registrar Of Indira Gandhi National Tribal University, Amarkantak and Dr Vishnu Narayan Mishra Associate Professor, Indira Gandhi National Tribal University, Amarkantak. This writ petition is filed on the ground that petitioner was a candidate for selection to the post of Associate Professor for which an advertisement was issued by the Indira Gandhi National Tribal University (IGNTU), Amarkantak. Petitioner's contention is that petitioner possesses qualification of M.Sc., M.Phil and Ph.D. in the relevant subject of Mathematics, therefore, he being more meritorious should have been selected for the post.

Several Congress leaders including former MLA join BJP ahead of Lok Sabha elections

BIG blow to the Congress party ahead of Lok Sabha elections as several Congress leaders, including a former MLA Dinesh Ahirwar and Congress District President from Vidisha, Rakesh Katare joined the BJP on Monday. Meanwhile, Madhya Pradesh Chief Minister Mohan Yadav, BJP state chief V D Sharma and others formally inaugurated the Lok Sabha Election Management Office in view of the upcoming Lok Sabha elections in the State BJP office in the state capital on Monday. State ministers, BJP officials and workers were also present on the occasion. CM Yadav posted on X, "Today, the state level Lok Sabha election office was inaugurated by performing puja according to the rituals at the state BJP office. The people of Madhya Pradesh have made up

their mind to bless Prime Minister Narendra Modi with victory in all the 29 Lok Sabha seats in the state. Ab ki baar 400 paar, phir ek baar BJP Sarkar." Earlier, Mayor of Jabalpur Municipal Corporation Jagat Bahadur Singh joined the saffron party on February 7. Singh had taken the Membership of the Bharatiya Janata Party (BJP) in the presence of BJP state chief VD Sharma, Chief Minister Mohan Yadav and cabinet ministers Prahlad Patel, and Kailash Vijayvargiya at BJP headquarters in Bhopal. Dindori district panchayat president Rudesh Paraste, Vice President Anju Beauhar, Congress ex-district president of Dindori Virendra Bihari Shukla and several other leaders had also joined the saffron party on that occasion. Kamal Nath posts message on Congress' ideology amidst reports of switching to BJP

Various crops damaged in Bichia after spell of hail

RAINFALL accompanied by hailstorm lashed the area on Monday night. The previous day was shrouded in overcast conditions. Affair and assault: Husband kills wife, tries to get deceased admitted into hospital

ON FEBRUARY 6, a man tried to get his wife admitted to the hospital in a dead state, the case has been disclosed today by the Dehat police station. Giving information about the case in the police control room, Additional SP, Avdesh Pratap Singh said that on February 6, information was received from the district hospital that a person named Raisingh Yadav from village Payali has admitted his wife Jaywati who was dead, with marks of assault on her body. On receiving the information, the body of the deceased immediately left for the district hospital, after

Panchnama the post mortum was done. The doctor said that Jaywati died due to injuries sustained in the assault. After this, a team was formed to investigate the entire matter and statements of the husband and other family members were taken, after which the entire matter was revealed. Police received information that Raisingh Yadav, a resident of Manka Dehi Khurd, had married Anita three years ago, with whom Raisingh had a son. Meanwhile, Raisingh had met Jaywati Uike, a resident of village Naulakhapa. What Jaywati had told to Raisingh was that she was previously married to Babu Dhurve, a resident of Veerdhana, Umreth. When

that Babu left her, Jaywati started living with Siyaram Kakodiya, a resident of Waranga. Later, Siyaram also left her and Jaywati and Raisingh started liking each other, then Jaywati started working as a labourer with Raisingh in Krishna Ingle Farm House in village Payali. He started living with Jaywati in the same room. Raisingh has a son from Jaywati who is about one and a half months old. Raisingh's wife Anita lived in Mankadehi. Raisingh had doubts about Jaywati's character from the beginning. She used to leave the small child and go missing for four to five days. When Jaywati did not agree to Raisingh's explanation, on February 5, Raisingh

beat her to death with a stick and with the intention of hiding the evidence, she wrapped Jayawati in a blanket and sent her to the district hospital so that no one could doubt it. After this, section 302, 201 IPC 3(2)(v) sc/st act was instituted and taken into consideration against accused Raisingh son of Lalu Yadav, resident of Mankadehi Khurd Hall village Payali Krishna Ingle Farm House, Chhindwara. The accused Raisingh Yadav is in the custody of the police. Accused Raisingh, who is in police custody, has confessed to the crime and recovered the black-barreled stick used in the incident. He has been sent to judicial custody.

THERE was hailstorm along with heavy showers in various areas of the district on the intervening night of February 10-11, due to which village wise joint investigation teams have been formed by the district administration in view of the possibility of damage to pulses and

other crops. For this, Tehsildars have been appointed as nodal officers for the concerned tehsil by Collector, Dr Saloni Sidana. The Collector has directed that a village wise joint investigation team consisting of Patwari from the Revenue Department, Rural Agriculture Extension Officer from the Agriculture Department and Gram Panchayat Secretary under the leadership of

Sub-Divisional Officer (RA), and Senior Agricultural Extension Officer will be formed to assess the damage in the hail affected villages. Instruction given to visit the areas and conduct a detailed survey in the presence of public representatives. According to 6-4RBC, after conducting spot investigation, assess the damage based on visual inspection and submit the survey report within the time limit.
